DECISION OF REGIONAL TRANSPORT AUTHORITY, VATAKARA MEETING HELD ON 27.10.2021 AT 10.30 AM BY VIRTUAL MODE.

Item No.1

"Heard. The learned counsel represented the applicant. This is an application for fresh regular stage carriage permit to operate on the route Mullambath-Thalassery. It is reported that the route overlaps the notified route for 2 kms from Thalassery to Saidarpally. Route length is 38 Kms. Secretary, RTA is specifically directed to report whether the overlapping exceeds the permissible limit. Road Fitness certificate from concerned authorities for the virgin portion on the route not obtained. Secretary, RTA shall make necessary arrangements to obtain the fitness certificate. Fare stages to be fixed, if any, on the virgin portion shall also be submitted. The proposed route is an inter-district one and a portion of the route falls within the jurisdiction of the RTA, Kannur. The Secretary RTA is directed to seek prior concurrence from the RTA, Kannur for the route portion lying within that authority. Hence **adjourned**".

Item No.2

"Heard. The learned counsel represented the applicant. This is an application for fresh regular stage carriage permit to operate on the route Ayanchery- Vatakara touching Malolmukku, Thanneerpanthal via Villiappally, Koottangaram as Ordinary service. The report of the enquiry officer reveals that the total length of the route is 21 Km. There is no overlapping with notified route/approved scheme in this proposal. Hence fresh regular stage carriage permit is **granted** to a suitable stage carriage subject to settlement of timings. The grantee of the permit is directed to produce the current records of a suitable stage carriage for endorsing the granted permit as specified in the decision of STA held on 16.01.2019 in Departmental item 1, that the upper age limit for applying and granting fresh regular permit to Ordinary, City/Town and LSOS stage carriage as eight years, within thirty days of communication of this decision as per Rule 159[2] of KMV Rules 1989; failing which the grant of the regular permit will be treated as revoked without further notice".

Item No.3

Heard. The learned counsel represented the applicant. This is an application for fresh regular stage carriage permit to operate on the route Pasukadav - Kuttyadi – Perambra – Kozhikode as LSOS (via) Mullankunnu, Ulliyeri, Atholi, Pooladikunnu Jn., Vengeri Jn., Karaparamb, Eranhipalam and Arayadathpalam. The enquiry officer reported that the route is beneficial to the passengers from Pasukadavu to Kuttyadi as it is an ill served area. But only one trip is proposed and it will not serve rural transportation needs. As per the timings only one trip is proposed to ill served area Pasukkadavu. Major area of operation is through well served are Kuttiady- Kozhikode. Hence the applicant is directed to provide two more round trips to ill served area Pasukkadavu and submit modified time sheet. Secretary RTA shall also submitted report regarding the necessity of a fresh limited stop service on this sector. For compliance of the above direction, decision on the application is **adjourned**".

"Heard. This is an application for fresh stage carriage permit in respect of S/C KL 15 A 0213 to operate on the route Thottilpalam-Civil- Kozhikode via. Kuttiadi, Perambra, Ulliyeri, Atholi received from MD, KSRTC. Fresh stage carriage permit **granted** with the proposed timings.

"Heard. This is an application for fresh stage carriage permit in respect of S/C KL 15 8379 Thottilpalam- Kozhikode Medical College via. Kuttiadi, Perambra, Ulliyeri, Atholi. received from MD, KSRTC. Fresh stage carriage permit **granted** with the proposed timings.

Item No.8

"Heard. The learned counsel represented the applicant. This is an application for variation of permit in respect of S/C KL-56-U-3252 operating on the route Chittarikkadavu- Koyilandy(via) Kavumvattam, Anela and Municipality. Variation requested is 1) Extending the trips from Kavumvattam to Chittarikkadavu (14 single trips) 2) Additional one round trip between Koyilandy and Thettikunnu via. Vydyarangadi. 3) Additional one round trip between Koyilandy and Kavumvattam via. Vydyarangadi. Frequency of service on the extended portion not reported by Secretary, RTA. Advantages and benefit to the travelling public by the proposed variation also need to be ascertained. Secretary RTA is directed to conduct a detailed enquiry on the above aspect and place before the next RTA. Hence **adjourned**.

Item No.9

"Heard. The learned counsel represented the applicant. This is an application for variation of permit in respect of S/CKL-10-Z 0297 permitted to operate on the route Ulloorkkadavu- Kannur Bazar- Kavalad Beach via Koyilandy, Madakkara. Variation requested is 1) Reduction of 6 trips from Koyilandy to Kavalad Beach via. Madakkara 6 trips. 2) Extending the route from Koyilandy to Poilkavu via. Harbour 5 trips.3) Extending the route from Koyilandy to Kappad via. Madakkara 1 trip.4) Extending the route from Koyilandy to Kannankadavu via. Madakkara 1 trip. Variation involves extension through ill served coastal area and is reported that the proposed variation is beneficial to the travelling public of interior area. Hence variation **granted** subject to settlement of timings.

Item No:10

"Heard. The learned counsel represented the applicant. This is an application for variation of permit in respect of S/C KL-56-C-3015 permitted to operate on the route Kozhikode-Payyoli Bus stand via. Koyilandy, Nandi Bazar, Keezhur, Payyoli cheerpu. Variation requested is 1) Curtailing the portion from Kizhur to Payyoli Cheerppu so as to extend the trip from Kizhur to Payyoli stand.2.Trip curtailment from Koyilandy to Kizhur (Koyilandy departure time 05.02 pm). 3) Re arrangement of trip for changing timings of existing morning trip between Koyilandy and Kozhikode.(Existing starting time from Koyilandy 5 28 am to evening proposed departure time from Koyilandy 5.10 pm).

The Enquiry Officer reported that the request of the permit holder is to change the existing timings and for curtailment from Kizhur to payyoli cheerp so as to extend the trip from Kizhur to Payyoli stand and for trip curtailment from Koyilandy to Kizhur. Change of existing timings and trips will affect the travelling public. Curtailmet of the portion of the route from Kizhur to Payyoli cheerp will adversely affect the travelling public of that area. Portion of the route lying between Kozhikode and Nandi bazaar is notified sector. As per clause 4 of the Notification No.G.O(P) No.8/2017/Tran dt. 23.03.2017 variation of permit on notified sector is not permissible in the private sector. Hence application for variation of permit is **rejected.**

ItemNo.11

"Heard. The learned counsel represented the applicant. Perused the judgment of Hon'ble STAT in MVARP No.166/2019 Dt.31.8.2021. This is an application for variation of permit in respect of S/C KL 58 B 189 permitted to operate on the route Ayancheri – Vatakara – Kozhikode as ordinary service. Variation requested is 1) Extension from Ayancheri to Kadameri 2 Kms. 2. Conversion of service to LSOS.

As per the judgment dated 31.08.2021 in MVAA No.166/2019, the Hon'ble Tribunal had directed this RTA to reconsider the application for conversion of service from OS to LSOS after finalisation of the draft notification after hearing all the affected parties including KSRTC and pass a speaking order on merits within 3 months of the finalisation of the notification. Draft notification not finalized till date. There are several objections received from the various corners including KSRTC for conversion of service as LSOS. Secretary RTA is directed to enquire and report the number of stage carriages conducting service on the whole route as LSOS and Ordinary services and submit detailed report before this authority Application shall be placed before the RTA on finalization of the draft scheme and the application shall be considered as per the terms and conditions of final scheme. Hence the decision on these applications is **adjourned**.

Item No.12

"Heard. 1) The learned counsel represented the applicant. The applicant requested to revoke the decision taken by RTA held on 03.02.2021 vide item No.5. Hence sanction is **revoked** without further notice. The applicant is directed to remit application fee for variation of permit.

2) This is an application for variation of permit in respect of S/C KL 13- U 7070 permitted to operate on the route Villiappalli- Vatakara- Kozhikode as Ordinary Service Variation requested is 1) Extension from Villiappally to Ayanchery 2) Conversion of service to LSOS. Variation requested is Extension of two single trips from Vadakara to Malol mukku 2) Curtailment-Two single trips from Koyilandy to Ulliyeri. As per the report of enquiry officer there is no urgent necessity as per KMVR 145 (6) for considering the proposed variations. Secretary RTA shall conduct an enquiry and report the details of

other stage carriages , if any; who have participated in the lightning strike on 16/09/2021 and place before this RTA for taking action.
