Decision of the Regional Transport Authority, Alappuzha held on <u>17.11.2022</u>

<u>Item No. : 01</u>

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of KL-05-T-4026 / suitable vehicle in the vacancy of KL 04 M 7475 on the route **Thottappally** - **Valiyazheeckal** via Thrikkunnappuzha, Arattupuzha for 5 years. On perusal of the file the Secretary RTA reported that there is no overlapping. Hence fresh regular permit in respect of KL-05-T-4026 / suitable vehicle in the vacancy of KL 04 M 7475 on the route **Thottappally** - **Valiyazheeckal** via Thrikkunnappuzha, Arattupuzha is **granted** for a period of 5 years subject to settlement of timings. The grantee is directed to produce the current records of KL 04 M 7475 / suitable vehicle within one month from the date of communication otherwise the sanction will be revoked.

<u>Item No. : 02</u>

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of KL-04-R-6194 on the route **Thoppilmukku - Karunagappally** via Thrikkunnappuzha, Valiyazheekal, Azheekal, Cheriyazheekal and Panikarukadavu for 5 years. This is an inter district route. Total distance of the route is 38.1 Kms, in which 16.6 Kms lies in Kollam district. Secretary RTA is directed to seek concurrence from RTA Kollam. Hence **adjourned**.

<u>Item No. : 03</u>

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of KL-04-V-4050 / suitable

vehicle on the route **Pandalam - Kayamkulam** via Edappone, Pattoor, Padanilam, Para, Charumoodu, Vettikode, Kattanam, Kuttitheruvu for 5 years. This is an inter district route. Total distance of the route is 29.4 Kms (Running 30.1, Railway Jn. to Railway station 0.7 km) in which 4.6 Kms lies in Pathanamthitta district. Secretary RTA is directed to seek concurrence from RTA Pathanamthitta. Hence **adjourned**.

<u>Item No. : 04</u>

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of KL-34-6859 on the route **Chengannur – Choonadu** via Puliyoor, Kadanmavu, Pottamelkadavu, Karayamvattom, Mavelikkara, Kallumala, Kurathikadu, Kattanam, Kuttitheruvu, 1st Mile Stone, Kayamkulam, Menatheri Jn., Kappilkuttipuram for 5 years. A distance of 7 kms from Kattanam to Kayamkulam Park Jn. in Kayamkulam-Punalur and Kayamkulam-Kulathupuzha partial exclusion scheme vide Notification No. GO(MS)156/67/PW dtd. 27.07.1967. As per Para 7 of this Notification only 24 Stage Carriage permits were allowed to operate. Moreover as per the Judgment of Hon'ble Supreme Court in M/s Adarsh Travels Bus Service and another Vs State of UP and others (AIR 1986 SC 319) and G.T. Venkataswamy Reddy Vs State Transport Authority and ORS. dtd. 19.07.2016 (Civil Appeal No. 480 of 1998) held that 'no private operator can operate his vehicle on any part or portion of a notified area or route unless authorised so to do by the term of the scheme itself'. Hence rejected.

Item No. 05

Heard the learned counsel represented the applicant. This is an application for variation of regular permit in respect of KL-39-G-7455 conducting service on the route Cherthala – Vyttila via Thavanakadavu – Pallichanda - Kalathil Temple – Thykkattussery - Poochakkal – Thaliaparambu - Perumbalam - Arookutty - Aroor Temple - Kumbalam **AS** Cherthala - Vyttila via Thavanakadavu - Pallichanda - Poochakkal - Perumbalam -Thaliaparambu - Arookutty - Kumbalam - Kundanoor. Perused the file and report. As per the report of enquiry officer, the absence of the service of this stage carriage through the curtailed portion in the morning from Aroor temple to Cherthala affect the travelling facility of the passengers of the curtailed portion of the route adversely. This is the first service from Aroor temple to Cherthala at 5.55 Am. From Poochakkal to Cherthala and from Thykkattussery to Cherthala one stage carriage each, is conducting service through the curtailed portion other than this service. In the rest of the curtailed portion no stage carriage is conducting service other than this service. Hence the curtailment of the service will adversely affect the travelling public. Hence **rejected.**

Item No. 06

Heard the learned counsel represented the applicant. This is an application for variation of regular permit in respect of KL-05-P-7317 on the route Eara - Ayiramthengu via Kurichy – Chethipuzha – Changanassery – Kavumbhagm – Mannar - Mavelikkara and Oachira **as** Kottayam - Ayiramthengu by curtailing the portion from Kurichy to Eara 3 kms and extending the route from Kurichy to Kottayam 19.9 kms. Perused the file and report. This was an adjourned item by RTA which held on 13/10/2021 for detailed report. The matter was enquired through MVI, SRTO, Kuttanadu which reveals the following; As part of this route where curtailment is sought viz:- Kurichy to Eara where many schools, College, Govt Officers are laocated namely Eara Krishi Bhavan, -known as Neelamperoor Krishi bhavan, Eara NSS h, RVLP School, Panchayath Office, Govt Ayurveda Hospital, South Indian Bank, Sark and Kalpaka Pepper factory, Neelamperoor LP School, PH Centre, SBI Kurichi Govt. HSS and St. Marys College etc, the Stage Carriage service in

this portion is beneficial to all sectors of the people living in this area and for those who are on daily commuting enroute for various purposes.

Several objections received from general public against the curtailment. KSRTC also raised strong objection that there is a scheme violation at a distance of 3 kms overlaps from Kottayam to Kanjikuzhy violating Clause 19 of Notification. The extended route length is 19.9 kms from Kurichi to Kottayam lies on Kottayam district. Also they objected that 3 number of trips increased in the Notified route Kottayam – Thekkadi and Eranakulam – Thekkadi, violating Clause 19 of Notification vide GO(P) No. 42/2009/ Trans dtd. 14.07.2009. **Hence rejected.**

<u>Item No. 07</u>

Heard the learned counsel represented the applicant. This is an application for variation of regular permit in respect of KL-03-N-8181(Old Vehicle KL 04 Q 9413) on the route Kayamkulam- Thiruvalla via Mavelikara and Mannar as Pullukulangara – Thiruvalla via Manivelikadav Jn, Kuttamvathukkal Bridge, Vadakke Anjilimoodu, Kamalalayam, Kayamkulam Chettikulangara, Mavelikara. Perused the file and report. The extension of service from Private Bus Stand Kayamkulam to Pullukulangara is beneficial to the travelling public and students. The area is thickly populated and no other stage carriage permit exists in the route. Hence variation of permit **allowed** subject to the settlement of timings.

Item No. 08

Heard the learned counsel represented the applicant. This is an application for variation of regular permit in respect of S/C KL-32-L-6080 conducting service on the route Cherthala – Vyttila via Vayalar – Nagamkulangara – Vayalar Kavala – Thuravoor – Chavady - Ezhupunna – Eramalloor - Aroor – Kumbalam - Madavana – Kundannoor **AS** Cherthala – Edapally – 1st and last trip via Cherthala – Edapally, 2nd trip via Cherthala - Vyttila. Perused the file and report. Secretary RTA reported that the absence of the service of this stage carriage through the curtailed portion in the morning Cherthala to Vyttila and return Vyttila to Cherthala affect the travelling facility of the passengers of the curtailed portion not adversely because other stage carriages and KSRTC are conducting service through this curtailed portion at that time. In addition, the extension is very beneficial to students and passengers. There are so many stage carriages conducting service through the curtailed portion other than this service. After variation total route length is 42 Kms, out of which 13.8 Kms lies in Eranakaulam district. Hence Secretery, RTA Alappuzha is directed to seek concurrence from RTA Eranakulam. Hence **adjourned**.

<u>Item No. 09</u>

Heard the learned counsel represented the applicant. This is an application for variation of regular permit in respect of S/C KL-06-G-6537 conducting service on the route Kavilpalli – Ernakulam – Kaloor via Valamangalam – Thuravoor – Chavady – Ezhupunna – Kumbalam – Vyttila - Kathrikadavu **As** 1st trip via Andhakaranazhy – Chavady – Eramalloor – Aroor – Kumbalam – Vyttila & K.K road and Last trip Ernakulam- Kaloor – Kavilpalli via K K road – Vyttila – Kumbalam – Aroor – Eramalloor – Chavady – Andhakaranazhy – Padmakshi Kavala. Perused the file and report. As per the report, 6.2 Kms overlaps from Eramalloor to Aroor Church Jn. Perused the file and report. After variation 15.8 Kms lies in Eranakulam district. Hence Secretary, RTA Alappuzha is directed to seek concurrence from RTA Eranakulam. Hence **adjourned**.

<u>Item No. 10</u>

Heard the learned counsel represented the applicant. This is an application for variation of regular permit in respect of KL-31-A-23 as Kayamkulam – Adoor Central via Kattanam, Nooranadu, Pazhakulam, HS, bye-pass. This was an adjourned item of RTA held on 13.10.2021. The counsel for the applicant prayed for adjournment and his request is allowed and this application is **adjourned**.

<u>Item No. 11</u>

Heard the learned counsel represented the applicant. This is an application for renewal of regular permit in respect of stage carriage KL 03 Q 7747 on the route Sasthamkotta - Chengannur via Bharanikav, Chakkuvally, Thamarakkulam, Charumoodu, Chunakara Market, Mankamkuzhy, Kochalumoodu, Kollakadav for a further period of 5 years w.e.f. 24/05/2021.

Perused the file and no HPA exists. This is an inter district permit and concurrence is not needed. The application was filed in time as per Section 81(2) of MV Act. Heard the learned counsel represented the applicant. Item No. : 114

Heard the learned counsel represented the applicant. This is an application for renewal of Regular Permit in respect of stage carriage KL-17-A-4980 operating on the route Pallithode Beach – Thavanakadavu Via Andhakaranazhy, Kadakkarapally, Thanky Jn, Ottapunna, Cherthala for a period of 5 years w.e.f. 26.03.2013, w.e.f. 26.03.2018 and request for replacement of vehicle with stage carriage KL-03-P-5556.

Application for renewal of permit was rejected by this authority in its meeting held on 21.12.2014, 12.03.2018, 11.07.2018 and 24.07.2019 consecutively for the reason that the permit holder failed to produce NOC from the financier. Against the above decision the permit holder filed an appeal before the Hon'ble State Transport Appellate Tribunal, in its order in MP No.153/2019 dtd. 06.08.2021, set aside the decision of this authority and directed to consider the application for renewal of permit and grant the same,

provided it satisfies the legal requirements contemplated under MV Act and Rules. The renewal application was again considered on merits and placed before the Regional Transport Authority and circulated the paper under Rule 130 and granted subject to the clearance of tax and other dues to Government, if any. The decision communicated to the permit holder on 26/02/2022 with direction to produce the current records of the vehicle within 30 days. But he failed to comply with the direction of RTA and STAT. Hence the renewal of permit granted on 26.02.2022 is **revoked**. Since the regular permit is not in existance, there is no question of replacement with a new vehicle. Hence application for replacement is also **rejected**.

<u>Item No. : 115</u>

This is the request of Secretary, RTA Eranakulam for variation of regular permit in respect of stage carriage KL-43-E-2324 operating on the route Kaloor – Eramalloor Via South, K K Road, Vyttila, Kundannur, Madavana and Aroor as mofussil service so as to extend first and nineth trips from Chellanam to Thankipally and extend 3rd trip from Gunduparambu to Chellanam.

Secretary RTA reported that the proposed variation (extension) portion 12 Kms is lying under the jurisdiction of RTA Alappuzha, place from South Chellanam to Thanki Palli (famous church pilgrim centre). No any overlapping in this proposed variation, no other stage carriages operating in this extension portion.

Hence concurrence is **granted** subject to the effect of Clause 5(c) of Notification No. 42/2009/Trans dtd. 14.07.2009 and 08/2017/Trans dtd. 23.03.2017 without prejudice to the right of the primary authority.

Hence the renewal of Regular Permit in respect of stage carriage KL 31 A 7196 on the route Kayamkulam- Adoor Central, Kattanam, Nooranad, Pazhakulam, Adoor High School is **granted** for a further period of 5 years w.e.f. 04.11.2021 subject to the clearance of all government dues if any.

This is the request of Secretary, RTA, Alappuzha to revoke the grant of renewal of regular permit by this authority held on 13.10.2021 in respect of stage carriage KL-08-AB-2728 on the route Cherthala – Kanichukulangara via Kuruppankulangara - Areeparambu w.e.f 06/02/2020. The applicant has not produced current records of the vehicle even after the maximum time granted as stipulated under rule 159(2). The applicant or representative not appeared to put forward any reason for this delay. Hence the grant of renewal of regular permit is hereby **revoked**.

This is the request of Secretary, RTA, Alappuzha to revoke the grant of renewal of regular permit by this authority held on 13.10.2021 in respect of stage carriage KL-18-B-5466 conducting service on the route Cherthala – Alappuzha Pvt. Bus stand via Kuruppankulangara – Areeparambu - Kanichukulangara – Mararikulam - Janatha Market - Kalavoor – Parthan Kavala - Ayyankali – Chathanadu - N C John company. The applicant has not produced current records of the vehicle even after the maximum time granted as stipulated under rule 159(2). The applicant or representative not appeared to put forward any reason for this delay. Hence the grant of renewal of regular permit is hereby **revoked**.

Item No. : S-01

Heard the learned counsel represented the applicant. Perused the Judgment of the Hon'ble High Court of Kerala in WP[©] No. 28/10/2022. Considered the applications for mutual replacement of vehicles covered by

regular permits KL 29 Q 5445 and KL 29 H 3330 operating on the route Kayamkulam - Chengannur.

Section 83 of Motor Vehicles Act allowed the vehicle replacement with the permission of the authority by which the permit was granted with a vehicle of same nature. As per Section 96 of Motor Vehicles Act, State Government is empowered to make rules for the purpose of Chapter V of Motor Vehicles Act. Based on the same state has formulated Kerala Motor Vehicles Rules 174 and as per Rule 174(2) the Regional Transport Authority may in his discretion reject the application for replacement with an old model vehicle. In this case of mutual or simultaneous replacement of KL 29 H 3330 (2014 model) by KL 29 Q 5445 (2019 model) is only legally permissible, on the other hand the other replacement of KL 29 Q 5445 (2019 model) by KL 29 H 3330 (2014 model) is not legally permissible as per Kerala Motor Vehicles Rules 174.

Hon'ble Supreme Court of India in Civil Appeal 1453-1454 of 2022 araising out of SLP (Civil) No. 13834-13835 of 2018 is also endorsed this Rule. Hence this application for mutual replacement of vehicles KL 29 Q 5445 and KL 29 H 3330 having regular permits on the route Kayamkulam – Chengannur is **rejected**.

Heard the applicants. This is an application for transfer of permit in respect of stage carriage KL-29 C 4554 on the route Keerikkad Jetty - Thiruvalla via Kayamkulam Chettikulangara, Thattarambalam, Mavelikara, Mannar, Podiyadi, and Kavumbhagam. Secretary RTA reported that the joint application is genuine and complies with the provisions of KMV Rule 178. Hence this authority **allowed** the transfer of permit from the name of Smt. Preetha Menon, Thushara, Ennakkad, Peringalippuram PO, Chengannur to the name of Sri. R Vijayakumar, Palamuttath, Peringala P O, Kayamkulam subject to the remittance of all government dues if any.
