<u>Item No. : 01</u>

Heard KSRTC. This is an application for the grant of fresh regular permit in respect of stage carriage KL 15 A 0100 on the route **Alappuzha – Arthunkal** - **Valiyazheeckal** for 5 years. Fresh regular permit **granted** subject to the production of current records of the vehicle.

Item No. : 02

Heard KSRTC. This is an inter district route. Total distance of the route is 36.8 Kms, in which 12.2 Kms lies in Kollam district. Secretary RTA is directed to seek concurrence from RTA Kollam. Hence **adjourned**.

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of stage carriage KL 07 AP 7509 on the route **MCH Vandanam – Cherthala Private Bus Stand** Via NSS Karayogam, Kuthirapanthy, Alappuzha Railway Station, General Hospital Jn, Alappuzha Private Bus Stand, Mararikulam, Kanichukulangara, Arthunkal, Thaickal, Madakkal for 5 years. On perusal of the file the Secretary RTA reported that there is no objectionable overlapping. Hence fresh regular permit in respect of stage carriage KL 07 AP 7509 on the route **MCH Vandanam – Cherthala Private Bus Stand** Via NSS Karayogam, Kuthirapanthy, Alappuzha

Railway Station, General Hospital Jn, Alappuzha Private Bus Stand, Mararikulam, Kanichukulangara, Arthunkal, Thaickal, Madakkal is **granted** for a period of 5 years subject to settlement of timings. The grantee is directed to produce the current records of the vehicle within one month from the date of communication, otherwise the sanction will be revoked.

<u>Item No. : 05</u>

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of stage carriage KL-Karunagappallv the Thoppilmukku 04-R-6194 on route _ via Valiyazheekal, Cheriyazheekal Thrikkunnappuzha, Azheekal, and Panikarukadavu for 5 years. Total distance of the route is 38.1 Kms, in which 16.6 Kms lies in Kollam district. Hence RTA held on 17.11.2022 adjourned this item for want of concurrence from RTA Kollam. RTA Kollam held on 19.07.2023 considered the concurrence request as item No.99 and concurrence granted. Hence fresh regular permit in respect of stage carriage KL-04-R-6194 the Thoppilmukku - Karunagappally on route via Thrikkunnappuzha, Valivazheekal, Azheekal, Cherivazheekal and Panikarukadavu is granted for a period of 5 years subject to settlement of timings. The grantee is directed to produce the current records of the vehicle within one month from the date of communication, otherwise the sanction will be revoked.

<u>Item No. : 06</u>

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of stage carriage KL 34/6859 on the route **MCH Vandanam – Chellanam** Via NSS Karayogam, Kuthirapanthy Alappuzha Railway Station, General Hospital Jn, Alappuzha Private Bus Stand, Mararikulam, Kanichukulangara, Arthunkal, Thaickal Beach, Ottamassery, Arattuvazhy, Andhakaranazhi, Pallithode for 5 years. KSRTC objected the grant of this permit, since the route overlaps more than 5 % of the total route length. Total route length is 51.6 Kms. Overlapping form General Hospital Jn to Pichu Iyer Jn is .7 Km and KSRTC Out Post to PH Bridge is 1.9 Kms. Total 2.6 Kms overlapping on this route. The learned counsel argued that the overlapping portion on the route is only 1.9 Kms. Hence **adjourned**. Secretary RTA is directed to obtain a specific report.

Item No. : 07

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of stage carriage KL 24 T 6828 on the route **Azheeckal Beach – Charummoodu** Via Perumpally, Pullukulangara, Kayamkulam, Kuttitheruvu, Mavelikkara, Kallumala and Mankankuzhy for 5 years. This is an inter district route. Total distance of the route is 39.4 Kms, in which 0.6 Kms lies in Kollam district. Secretary RTA is

directed to seek concurrence from RTA Kollam and get details of route from Mavelikkara to Charummoodu with route sketch. Hence **adjourned**.

<u>Item No. : 08</u>

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of suitable stage carriage on the route **Puthanambalam – Ambalapuzha Temple Jn** via Muhamma, Mangalapuram, Ambalamukk, Asramam, Alappuzha Railway Station, Thriveni, Kuthirappanthy, Punnapra Harbor, Vandanam and Vyasa Jn for 5 years. On perusal of the file the Secretary RTA reported that there is no objectionable overlapping. **Adjourned** for clarity in the fare stage fixed in the report submitted by Motor Vehicles Inspector.

Item No. : 09

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of suitable stage carriage on the route **MCH Vandanam – Thaickal Beach** via NSS Karayogam, Kuthirappanthy, Alappuzha Railway Station, General Hospital Jn, Alappuzha Private Bus Stand, Mararikulam, Kanichukulangara, Arthunkal for 5 years. KSRTC objected the grant of this permit, since the route overlaps more than 5 % of the total route length. Total route length is 39.5 Kms. Overlapping form General Hospital Jn to Pichu Iyer Jn is 0.7 Km and KSRTC Out Post to PH Bridge is 1.9 Kms. Total 2.6 Kms overlapping on this route. The learned counsel argued that the overlapping portion on the route is only 1.9 Kms. Hence **adjourned**. Secretary RTA is directed to obtain a specific report.

<u>Item No. : 10</u>

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of suitable stage carriage on the route **Ochira DB - Chengannur** Via Choonad, Thamarakkulam, Charummood, Mamkamkuzhy, Kollakadavu, Puliyoor for 5 years. This is an inter district route. Total distance of the route is 37.1 Kms, in which 0.5 Km lies in Kollam district. Secretary RTA is directed to seek concurrence from RTA Kollam. Hence **adjourned**.

<u>Item No. : 11</u>

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of suitable stage carriage on the route **Thekke Chellanam – Alappuzha Railway Station** Via Pallithode, Azheeckal, Thanki Church, Arthunkal, Mararikulam, Malikamukku, Pvt Bus Stand, Jetty, General Hospital, Collectorate Jn for 5 years. On perusal of the file the Secretary RTA reported that there is no objectionable overlapping. Hence fresh regular permit in respect of suitable stage carriage on the route **Thekke Chellanam – Alappuzha Railway Station** Via Pallithode, Azheeckal,

Thanki Church, Arthunkal, Mararikulam, Malikamukku, Pvt Bus Stand, Jetty, General Hospital, Collectorate Jn is **granted** for a period of 5 years subject to settlement of timings. The grantee is directed to produce the current records of the vehicle within one month from the date of communication, otherwise the sanction will be revoked.

<u>Item No. : 12</u>

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of stage carriage KL-04-V-4050 / suitable vehicle on the route Pandalam - Kayamkulam via Edappone, Pattoor, Padanilam, Para, Charumoodu, Vettikode, Kattanam, Kuttitheruvu for 5 years. Total distance of the route is 29.4 Kms (Running 30.1, Railway Jn to Railway Station 0.7 Km) in which 4.6 Kms lies in Pathanamthitta district. Hence RTA held on 17.11.2022 adjourned this item for want of concurrence from RTA Pathanamthitta. RTA Pathanamthitta held on 04.10.2023 considered the concurrence request as item No.99 and concurrence granted. The portion of the route from Kayamkulam to Para Jn a distance of 15.5 Kms overlaps on complete exclusion scheme Kayamkulam - Punalur & Kayamkulam – Kulathupuzha and no new permits can be granted to a private operator. Hence **rejected**.

Item No. 13

Heard the learned counsel represented the applicant. This is an application for variation of Regular Permit in respect of stage carriage KL 42/3549 on the route Mannanchery - Alappuzha Railway Station, via Komalapuram, Jetty, MCH by extending from Mannanchery - Ponnad, via Ambalakkadav. KSRTC objected the grant of variation due to the violation of complete exclusion scheme Alleppey - Thaneermukkam and Alleppey - Muhamma vide GO(MS) 42/74/PW dtd 14.08.1974. Enquiry officer reported that No variation is permissible in the existing permit since it is a saved permit, overlapping 9.7 Km through Alleppey-Thaneermukkam and Alleppey Muhamma complete exclusion scheme. Hence extension of service from Mannancherry to Ponnad **rejected**.

<u>Item No. 14</u>

Heard the learned counsel represented the applicant. This is an application for variation of Regular Permit in respect of stage carriage KL 07 BB 9809 on the route Kattakuzhi - Alappuzha via Koparakadav, SN Junction, Paravoor, General Hospital Jn and Jetty As Pandarakulam - Alappuzha. Enquiry officer reported that proposed starting point Pandarakulam is not a place where a stage carriage vehicle can park or turn in compliance with road safety aspects. A distance of 11 Km (62.14% of the total route length 17.7 Km) from SN Jn to Pichu Iyyer Jn overlaps on Trivandrum - Palakkad partial exclusion scheme vide clause 19 of G.O(P) No. 13/2023/Trans dtd.03.05.2023.

RTA has no authority to vary the conditions of the existing permit. Hence **rejected**.

<u>Item No. 15</u>

Heard the learned counsel represented the applicant. This is an application for variation of Regular Permit in respect of stage carriage KL 04 U 2244 on the route Parumala Church - Chengannur via Budhanoor, Puliyoor for an additional trip between Parumala Church – Chengannur. Secretary RTA is directed to furnish specific report. Hence **adjourned**.

<u>Item No. 16</u>

Heard the learned counsel represented the applicant. This is an application for variation of Regular Permit in respect of stage carriage KL 17 E 8898 on the route Thottapally - Valiyazheekkal via Thruikkunnapuzha, Thottapally Arattupuzha, Perumpally As Mundukotta _ in. via Thrikkunnapuzha, Arattupuzha, Perumpally, Valiyazheekkal, Azheekkal, Ayiramthengu, Vallikav Jn. by extending the route from Valiyazheekkal to Mundukotta Jn(Oachira). A distance of 7.7 Kms lies in Kollam district. Hence RTA held on 08.03.2023 adjourned this item for want of concurrence from RTA Kollam. RTA Kollam held on 19.07.2023 considered the concurrence request as item No.100 and concurrence granted. Hence variation is granted subject to settlement of timings.

<u>Item No. 17</u>

Heard the learned counsel represented the applicant. This is an application for variation of Regular Permit in respect of stage carriage KL 61 G 459 on the route Karunagapally HS - Pandalam, via TB Hospital, Puthiyakav, Aramathumadam, Thamarakulam, charumoode, Nooranad, Kudassanad. Request is to change the timings of 1st trip from Manapally as 6.10 Am and arrival at Charumood as 6.45 Am and change the departure as 6.50 am and curtailing the portion from Pandalam to Karunagapally and for changing the timing from Karunagapally as 1.12 Pm instead of 1.10 Pm. As per the report of field officer this proposal adversely affect the interest of public as it takes away the existing early morning public transport facility from a rural area like Manapally to an important destination in the neighboring district (Pandalam) directly. Moreover this would result in loss of income to the operator as the major portion of the route is being cut away and may naturally feel reluctance in prompt and punctual operation. Hence **rejected**.

<u>Item No. 18</u>

Heard the learned counsel represented the applicant. This is an application for variation of Regular Permit in respect of stage carriage KL 29 J 0234 on the route Veeyapuram - Chengannur via Pallippad, Haripad, Nangiarkulangara, Thattarambalam, Mavelikara, Kollakadav, Kodukulanji, and Poralassery As Chengannur - Mannarasala by curtailing Veeyapuram - Haripad and extending Haripad – Mannarasala Temple. The matter was considered by RTA held on 08.03.2023 and adjourned with a direction to Secretary RTA to ascertain the number of services and timings on the curtailed and extended portion". Now the secretary RTA reported that there are 52 stage carriages operating through the route from Harippad to Veeyapuram in the time between 6.30 am to 6.30 pm and six stage carriages operating in between 6.10 Pm to 9.10 Pm. In light of the above reason curtailment will not adversely affect the travelling facility of the public and students in that area. Also reported that the extension from Harippad to Mannarasala will be favourable in the travelling facility of the students and public of that region since the famous pilgrim centre Mannarasala temple is located in that area. Hence variation is **granted** subject to settlement of timings.

Item No. 19

Heard the learned counsel represented the applicant. This is an application for variation of Regular Permit in respect of stage carriage KL 02 W 4599 on the route Choolatheruv - Mavelikara, via Muthukulam, Pullukulangara, Pallimukku, ONK Junction. KSRTC. Kuttitheruv, Olakettiyambalam As Thrikkunnapuzha - Mavelikra by extending the route from Choolatheruv to Thrikkunnapuzha. Kayamkulam to Kuttitheruv a distance of 6 Kms overlaps on Kayamkulam - Punaloor and Kayamkulam -Kulathupuzha partial exclusion scheme. Hon'ble High Court of Kerala in WP(C) No. 19433 of 2021 dtd. 03.11.2023 confirmed that partial overlapping has no difference from complete exclusion. Hence the variation cannot be granted. Hence **rejected**.

Item No. 20

Heard the learned counsel represented the applicant. This is an application for variation of Regular Permit in respect of stage carriage KL-32-A-9580 conducting service on the route Cherthala - Vyttila via Ottappunna - Pallichanda - Poochakkal - Perumbalam -Arookutty - AroorChurch - Kumbalam As Cherthala - Edappally Toll via Thavanakkadavu - Poochakkal - Perumbalam - Arookutty - Aroor Temple - Kumbalam and Vyttila by extending the route from Vyttila - Edappally Toll. The extension from Vyttila - Edappally Toll which lies in the jurisdiction of RTA Eranakulam. Hence Secretary RTA is directed to seek concurrence from RTA Eranakulam. Hence **adjourned**.

<u>Item No. 21</u>

Heard the learned counsel represented the applicant. This is an application for variation of Regular Permit in respect of stage carriage KL-16-J-7576 conducting service on the route Cherthala - Alappuzha via Malikamukku - Thumpoly – Kattoor – Mararikkulam – Arthunkal – Thaickal -Madackal As Cherthala – MCH Vandanam via Railway Gate – Kuttikkad –Thaickal -Arthunkal Church – Pollethai - Thumboli Church – Malikamukku -KSRTC Out Post - ESI Hospital - Thriveni Junction - Paravoor West - Punnapra Beach LPS by extending the route from Alappuzha to MCH Vandanam. A distance of 0.7 Km from General Hospital Jn to Pitchu Iyer Jn and 1.9 Kms from KSRTC Out Post to P.H Bridge (5.93% of the total route length 43.8 Km) overlaps on Thiruvananthapuram - Palakkad & Thiruvananthapuram - Kannur scheme vide clause 19 of G.O(P) No. 13/2023/Trans dtd.03.05.2023. RTA has no authority to vary the conditions of the existing permit. Hence **rejected**.

Item No. 22

Heard the learned counsel represented the applicant. This is an application for variation of Regular Permit in respect of stage carriage KL-07-AZ-8949 conducting service on the route Alappuzha - Cherthala via PH Bridge – Malikamukku - Thumpoly Church – Kattoor – Mararikkulam - Arthunkal As Cherthala – MCH Vandanam via Railway Gate – Kuttikkad – Thaickal - Arthunkal Church – Pollethai - Thumboli Church – Malikamukku - KSRTC Out Post - ESI Hospital - Thriveni Junction - Paravoor West - Punnapra Beach LPS by extending the route from Alappuzha to MCH Vandanam. A distance of 0.7 Km from General Hospital Jn to Pitchu Iyer Jn and 1.9 Kms from KSRTC Out Post to P.H Bridge (5.93% of the total route length 43.8 Km) overlaps on Thiruvananthapuram - Palakkad & Thiruvananthapuram – Kannur scheme vide clause 19 of G.O(P) No. 13/2023/Trans dtd.03.05.2023. RTA has no authority to vary the conditions of the existing permit. Hence **rejected**.

Item No. 23

Heard the learned counsel represented the applicant. This is an application for variation of Regular Permit in respect of stage carriage KL 37 7808 on the route Thiruvalla - Manivelikadav, Kavumbhagam, Podiyadi, Parumala, Mavelikara, Thattarambalam, Chettikulangara, Kayamkulam KSRTC, ONK Jn, Pallimmukku, Pullukulangara As Thiruvalla - Kayamkulam by curtailing the route from Kayamkulam to Manivelikadav for a distance of 8 Kms. Enquiry officer reported that the curtailment of trips between Kayamkulam and Manivelikadav may adversely affect the conveyance of the public on the route, especially for the passengers from Manivelikadav. Hence **rejected**.

Item No. 24

Heard the learned counsel represented the applicant. This is an application for variation of Regular Permit in respect of stage carriage KL-04-U-3945 conducting service on the route Cherthala - Vyttila via Poochakkal, Thavanakkadavu, Thykkattusserry, Thrichattukulam and Aroor Temple As Cherthala - Vyttila Hub via Poochakkal, Thavanakkadavu, Thykkattusserry, Thrichattukulam, Aroor Temple and Vyttila by extending the 6th trip from Aroor Temple Jn to Vyttila Hub. The area of proposed extension lies in the jurisdiction of RTA Eranakulam. Hence Secretary RTA is directed to seek concurrence from RTA Eranakulam. Hence **adjourned**.

<u>Item No. 25</u>

Heard the learned counsel represented the applicant. This is an application for allotment of passing time of intermediate points in respect of stage carriage KL-05-Y-3078 conducting service on the route Cherthala - Alappuzha via Arthunkal, Mararikkulam, Kattoor, Thumpoli. Secretary RTA is directed to consider the application and do the needful. Hence **adjourned**.

Item No. 26

Applicant or authorized person not appeared for hearing before this authority. Hence **adjourned**.

Item No. 27

Heard the learned counsel represented the applicant. This is an application for change of halting place from Cherthala to Arthunkal. Enquiry officer reported that several stage carriages operate from Arthunkal to Cherthala and Cherthala to Thuravoor, the curtailment will not significantly affect the travelling public and students. Students from Thaickal to Pallithode is included in the coastal road category. Public transport is inadequate in these areas. Therefore, the proposed variation will be beneficial to passengers including fishermen and students in these areas, the proposed variation comes under the jurisdiction of RTA, Alappuzha and no additional overlaps in the notified route. Hence variation is **granted** subject to settlement of timings.

MVAA No. 28/2022 against the decision of this authority held on 08.03.2023 is pending before the Tribunal. Hence **adjourned**.

This is an application for renewal of Regular Permit in respect of stage carriage KL-06-F-5817 conducting service on the route Cherthala - Edakochi via Ottappunna – Thavanakadavu – Poochakkal – Arookutty - Aroor Temple for a further period of 5 years w.e.f. 12.07.2023. This permit was issued prior to 14.07.2009 and is a long standing permit. Perused the file and no HPA exists. This is an inter district permit and concurrence is not needed. The application was filed in time as per Section 81(2) of MV Act. KSRTC has raised no objection regarding the renewal. STU has not filed any application on this route. This permit was issued prior to 14.07.2009 and is a long standing permit. Perused the file and no HPA exists. This is an inter district permit and concurrence is not needed. KSRTC appeal that as per the clause 4,5 and 7 of the above notification No. GO(MS) 156/67/PW dtd.27.07.1967, only 24 private operators are described in the Appendix B list attached to the notification is allowed to operate on the scheme routes. This authority in item No.104 decided to seek clarification from Goernment regarding the renewal of regular permit, which overlapping Kayamkulam – Punalur and Kayamkulam – Kulathupuzha schemes. Hence **adjourned** the application with direction to Secretary RTA to issue temporary permit as per section 87(1)(d) till the disposal of renewal application.

Item No. 57

Heard the learned counsel represented the applicant. This is an application for renewal of regular permit in respect of stage carriage KL 04 U 8611 on the route Karthikapally - Mavelikara, via SNDP HS, Choolatheruv, Vettathukadav, Kanakakunnu, Kocheede Jetty, Pullukulangara, ONK Jn, KSRTC Pvt Bus Stand, Kuttitheruv, Olakettiyambalam for a further period of 5 years w.e.f. 09.10.2021.

On perusal of the file it is found that this is a belated application and request for delay condonation accepted, no HPA exists. Perused the report of Secretary RTA. On hearing KSRTC strongly objected the grant of this permit since it is a clear violation of Kayamkulam - Punalur and Kayamkulam -Kulathupuzha partial exclusion scheme of KSRTC vide notification No. GO(MS) 156/67/PW dtd.27.07.1967. A distance of 2.80 Km from Kayamkulam Pvt Bus Stand to Kuttitheruvu overlaps these schemes and a distance of 0.70 Km from ONK Junction to Kayamkulam overlaps on Thiruvananthapuram - Palakkad scheme SRO 348/66. KSRTC appeal that as per the clause 4,5 and 7 of the above notification No. GO(MS) 156/67/PW dtd.27.07.1967, only 24 private operators are described in the Appendix B list attached to the notification is allowed to operate on the scheme routes. This authority in item No.104 decided to seek clarification from Goernment regarding the renewal of regular permit, which overlapping Kayamkulam - Punalur and Kayamkulam - Kulathupuzha schemes. Hence **adjourned** the application with direction to Secretary RTA to issue temporary permit as per section 87(1)(d) till the disposal of renewal application.

<u>Item No. 58</u>

Heard the learned counsel represented the applicant. This is an application for renewal of regular permit in respect of stage carriage KL 04 P 5194 on the route Veeyapuram - Choonad via Harippad, Danappady,

Karthikapally, Muthukulam, Pullukulangara, Kayamkulam, Onnamkutti for a further period of 5 years w.e.f. 19.10.2020.

On perusal of the file it is found that this is a belated application and request for delay condonation accepted, no HPA exists. Perused the report of Secretary RTA. On hearing KSRTC strongly objected the grant of this permit since it is a clear violation of Kayamkulam - Punalur and Kayamkulam -Kulathupuzha partial exclusion scheme of KSRTC vide notification No. GO(MS) 156/67/PW dtd.27.07.1967. A distance of 1.50 Km from Kayamkulam to Onnamkutty overlaps these schemes, a distance of 1.70 Km from Harippad to Danappady overlaps on Thiruvananthapuram - Palakkad scheme SRO 348/66 and a distance of 7.7 Kms from ONK junction to Kayamkulam overlaps on Thiruvananthapuram - Palakkad scheme SRO 348/66. KSRTC appeal that as per the clause 4,5 and 7 of the above notification No. GO(MS) 156/67/PW dtd.27.07.1967, only 24 private operators are described in the Appendix B list attached to the notification is allowed to operate on the scheme routes. This authority in item No.104 decided to seek clarification from Goernment regarding the renewal of regular permit, which overlapping Kayamkulam -Punalur and Kayamkulam - Kulathupuzha schemes. Hence adjourned the application with direction to Secretary RTA to issue temporary permit as per section 87(1)(d) till the disposal of renewal application.

<u>Item No. 59</u>

Heard the learned counsel represented the applicant. This is an application for renewal of Regular Permit in respect of stage carriage KL 29 B 3300 on the route Mannarasala - Chengannur via Harippad, Kavala, Mavelikara for a further period of 5 years w.e.f. 23.07.2022. This permit was issued prior to 14.07.2009 and is a long standing permit. Perused the file and no HPA exists. This is a belated application and request for delay condonation accepted. KSRTC has raised no objection regarding the renewal. STU has not filed any application on this route. Hence the renewal of regular permit in respect of stage carriage KL 29 B 3300 on the route Mannarasala - Chengannur via Harippad, Kavala, Mavelikara is **granted** for a further period of 5 years w.e.f. 23.07.2022 subject to the clearance of all government dues if any.

<u>Item No. 60</u>

Heard the learned counsel represented the applicant. This is an application for renewal of regular permit in respect of stage carriage KL 29 H 8201 on the route Arattupuzha - Thiruvalla via Karthikapally for a further period of 5 years w.e.f. 20.02.2021. This permit was issued prior to 14.07.2009 and is a long standing permit. Perused the file, HP exists and NOC from Financier produced. This is an inter district permit and concurrence is not needed. This is a belated application and request for delay condonation accepted. KSRTC has raised no objection regarding the renewal. STU has not filed any application on this route. Hence the renewal of Regular Permit in

respect of stage carriage KL 29 H 8201 on the route Arattupuzha - Thiruvalla via Karthikapally is **granted** for a further period of 5 years w.e.f. 20.02.2021 subject to the clearance of all government dues if any.

<u>Item No. : 61</u>

Heard the learned counsel represented the applicant. This is an application for renewal of reserve permit in respect of stage carriage KL 04 P 5389 for conducting substitute service in place of stage carriages KL 04 P 5426 (Thrikkunnapuzha - Changanassery), KL 04 U 8611 (Choolatheruv - Mavelikara) KL 29 B 3314 (Puthukulam - Manivelikadav) KL 29 3317 (Choolatheruv - NTPC Kayamkulam), KL 29 H 8201 (Arattupuzha - Thiruvalla), KL 29 H 8096 (Kayamkulam - Changanassery for a further period of 5 years w.e.f. 10.03.2023. Adjourned for want of tax details. Secretary RTA is directed to furnish the tax possession of route buses as per SRO 880/1975 and permit possession of KL 29 3317.

<u>Item No. 62</u>

Heard the learned counsel represented the applicant. This is an application for renewal of regular permit in respect of stage carriage KL-18-B-1068 conducting service on the route Cherthala - Vyttila Bus Stand via Poochakkal. This permit was issued on 19.08.2013 ie, after the date of publication of the notification GO(P) No. 42/2009/Trans dtd. 14.07.2009 and GO(P) No. 08/2017/Trans dtd. 23.03.2017. Perused the file. HP exists and NOC from Financier produced. This is a belated application and request for delay condonation accepted. KSRTC has raised no objection regarding the renewal. STU has not filed any application on this route. Hence the renewal of Regular Permit in respect of stage carriage KL-18-B-1068 conducting service on the route Cherthala - Vyttila Bus Stand via Thavanakkadavu. Poochakkal. Perumbalam, Palliveli, Ulavaipu. Thrichattukulam, Arookutty, Aroor Temple and Kumbalam is granted for a further period of 5 years w.e.f. 19.08.2023 subject to the clearance of all government dues if any.

<u>Item No. 63</u>

Heard the learned counsel represented the applicant. This is an application for renewal of regular permit in respect of stage carriage KL 04 P 4281 on the route Keerikkad Jetty - Adoor Central via Pullukulangara, Kayamkulam, Nooranad w.e.f. 13.07.2008 and for replacement of this vehicle by KL 17 D 9857.

 The stage carriage KL 04 P 4281 was covered by a regular permit on the route Keerikkad Jetty - Adoor Central which was expired on 12.07.2008. The present application for renewal of regular permit was submitted on 24.05.2023 by Sri. Sathyapalan Unnithan. While considering this application, it was found that a regular permit was granted to Sri. Anil, on the above defaulted vacancy of KL 04 P 4281. But later on 11.07.2018 the renewal of this permit was rejected by this authority due to overlappings on notified routes. A modified proposal based on Hon'ble STAT's order was again considered by this authority on 13.10.2021 and adjourned for detailed report and directed Sectary to issue temporary permit Under Section 87(1)(d) for the continuance of the vehicle. Then on 08.03.2023 it was rejected due to overlappings on Kayamkulam – Kulathupuzha partial exclusion scheme. Which restrict the operation of private operators on this route. This decision was in line with judgment of Hon'ble STAT in MVAA number 42/2021 and which was confirmed by Hon'ble High Court in its judgment WP(C) 19433 of 2021 dated 03/11/2021. This decision on this authority is also challenged before the Hon'ble STAT and as per the order of the Hon'ble Tribunal, Secretary is issuing 20 days temporary permits for continued operation of this vehicle.

In this situation the application of Sri Sathyapalan Unnithan for the renewal of regular permit and replacement is considered. The regular permit issued to the applicant was expired on 12.07.2008, that is more than 15 years ago. As per Section 81(2) of Motor Vehicles Act, a permit may be renewed on an application made not less than 15 days before the date of expiry. Here no such application is received in time. Hence the present application cannot be considered as an application for renewal of permit. More over the route from Kayamkulam to Adoor Central a distance of 29.2 kms overlaps the partial exclusion scheme of Kayamkulam - Kulathupuzha and Kayamkulam - Punalur. From Adoor High School Junction to Adoor Central a distance of 1.5km overlaps on Trivandram - Thekkady supplementary scheme, from ONK Jn to Kayamkulam a distance of 700 meters overlaps on Kollam - Alappuzha complete exclusion scheme. So no permit can be granted to private operators on the above routes in violation of notifications. In addition to this, an application after the expiry of 15 years cannot be considered as an application for renewal of permit in violation of Sec.81(2) of Motor Vehicles Act.

2. The second application is for replacement of stage carriage KL 04 P 4281 by KL 17 D 9857. This also considered and found that this cannot be allowed at one shot. Since as per the Hon'ble High Court of Kerala's Judgement in Usman vs Regional Transport Authority, Malappuram and another (2015 (4) KHC 779) only a holder of permit can apply for replacement of vehicle with another. Hence **rejected**.
