"Heard the learned counsel Adv. O.D. Sivadas represented the applicant.

Applicant is the person holding permit [01/10032/1995] to operate a stage carriage on the route **THUMBA ISRO JUNCTION - PAPPANAMCODE** Via. Poundukadavu, Veli, Kochuveli, Allsaints, Pettah, Vanchiyoor, GH jn, Palayam, Statue, OB, EF, Thampanoor And Karamana. Permit holder is conducting service through this route with a leased stage carriage bearing reg no. KL 02 AM 3232. The route length is 25 kms.

1. There are some points between the starting point THUMBA ISRO JUNCTION and the first intermediate point Poundukadavu, which is not mentioned in the permit.
2. Due to the above, some misunderstandings happened between the permit holder and KSRTC leading to arguments, complaints etc.
3. Based on this reason the permit holder applied for re verifying the route and for adding missing points between THUMBA ISRO JUNCTION and Poundukadavu stating that they are facing difficulty in conducting service.
4. As per the request enquiry had been conducted by field officer and the route was re verified.
5. Field officer reported that Pallithura, Nehru Junction, Stationkadavu are the left out intermediate points coming between THUMBA ISRO JUNCTION and Poundkadavu which can be added in the permit without altering the current route length, terminees etc..

Based on the above findings the application for adding left out points in permit [01/10032/1995] to operate a stage carriage on the route **THUMBA ISRO JUNCTION - PAPPANAMCODE** Via. Poundukadavu, Veli, Kochuveli, Allsaints, Pettah, Vanchiyoor, GH jn, Palayam, Statue, OB, EF, Thampanoor And Karamana is **granted** hereby adding intermediate points Pallithura, Nehru Junction, Stationkadavu between THUMBA ISRO Jn and Poundkadavu making Via as **Pallithura, Nehru Junction, Stationkadavu, Poundukadavu, Veli, Kochuveli, Allsaints, Pettah, Vanchiyoor, GH jn, Palayam, Statue, OB, EF, Thampanoor And Karamana** without changing route length, time schedule etc.. The modification is done subject to the production of NOC from the finance company and clearing of Government dues, if any.

“Request for delegating power to the Secretary RTA for renewing the saved regular permit of the stage carriages without placing it before the RTA board meeting is objected by the K.S.R.T.C.

Objection of KSRTC

KSRTC objected the matter stating that, Thiruvananthapuram is a notified area and as per the 1994 notification Trivandrum city and moffusil routes are exclusively reserved for the State Transport Undertaking, similarly some of the routes in the G.O (P) 3/2023 Tran, dtd 03/05/2023 scheme is also passing through Trivandrum, all of these schemes having different provisions to issue fresh permits/renew the existing permits to the private stage carriages operators. As per S 104 of the MV Act 1988 the RTA/STA shall not grant any permit except in accordance with the provision of the approved scheme, the scheme and the provision of Chapter VI of the MV Act having overriding effect notwithstanding any thing inconsistent therewith contained in Chapter V or in any other law for the time being in force or in any instrument having effect by virtue of any such law, matters are being so, if the power delegated to the secretary, RTA, without placing the renewal application before this honorable authority may cause to renew the permits which are violating the approved schemes.

Findings of the Authority


Saved permits are the 100 city permit routes allotted to the private stage carriages to operate in Thiruvananthapuram City vide G.O (P) No 108/1994 dated.24.11.1994. long before the notification G.O (P).42/2009 dtd. 14/07/2009.

KSRTC strongly objected this item stating that most of the routes covered by the permits are came under the notification G.O (P).42/2009 dtd. 14/07/2009.

Hence based on the above findings this authority is **hereby rejected the delegation** of power to the Secretary RTA for renewing the saved regular permit of the stage carriages without placing it before the RTA.

This authority perused the connected documents and files and the following matters were observed.


