

**DECISION OF REGIONAL TRANSPORT AUTHORITY, WAYANAD, DATED 04/02/2025****Item No. 1**

Heard. Reconsidered the application for fresh regular permit on the route Meenangady-Kambalakkad via Karani, Kalluvayal Colony, Kumbalad, Paralikunnu, Chelanjikkal, Pariyaram, Parakkal and Muttill as ordinary service. It is reported that the route covers the remote areas of Muttill Panchayath and the introduction of service is beneficial to the tribal, students and the public. There is no objectionable overlapping with the notified route of KSRTC. Hence regular permit **granted** to S/C KL11AL5526, subject to settlement of timings.

**Item No. 2**

Heard. Reconsidered the application for fresh regular permit on the route Kattikulam- Bavali-Payyampally- Mananthavady- Pancharakkolly as ordinary service ~~as ordinary service~~. The virgin portion fro 6.1 KMs reported and fitness certificate received from concerned authority. The proposed route covers the remote areas of Mananthavady Municipality and Thirunelly Grama panchayath. It is also reported that the route is beneficial for traveling public. Hence regular permit **granted** to S/C KL13L2807, subject to settlement of timings.

**Item No. 3**

Heard. Regular permit was granted by this authority in the meeting held on 12/07/2023 vide item no.81. The decision was communicated to the grantee with direction to produce the current records of the vehicle within one month. The grantee produced the records of S/C KL07BE1281 only on 15/01/2025, with request to condone the delay. Rule 159(2) of KMV Rules specifies that the applicant within one month of the sanctioning of application by the authority or periods not exceeding four months produce the certificate of registration of the vehicle to avail the permit. The grantee failed to produce the current records within the stipulated time. Hence the request to condone the delay is denied. The order of this authority granting the permit is **revoked**.

This authority cannot review its own decision and the appeal in MVAA No. 189/2024 filed by the permit holder is still pending before the appellate authority (Hon'ble STAT). The compounding fee related to each offence in the challan prepared shall be remitted by the offender. This authority also decides to suspend the permit of the above stage carriages for a period of 15 days from 15/03/2025. The permit holder shall intimate the place of garage of the vehicle during the period of suspension and Secretary RTA shall watch the service of the vehicle during this period. The permit holder is also given an option to compound the offence for an amount of Rupees 1000 per day in lieu of suspension.
