ITEM No.01

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular stage carriage permit on the route **Mallappally-Edamon** (Via) Cherthodu, Padimon, Kulathurmoozhi, Perumpetty, Chunkappara, Melekavala, Ponthenpuzha, Mukkada, Vakathanam for a suitable stage carriage for a period of 5 years as ordinary service.

Enquiry report of Joint RTO Mallappally reveals that the total route length is $27.9~\rm km$ out of which $21.5~\rm km$ lies in Pathanamthitta district and $6.4~\rm km$ in Kottayam District. This authority on 04/10/2023 considered the application and adjourned for want of concurrence from RTA Kottayam .

On hearing, K.S.R.T.C raised timing objection only. On the strength of concurrence granted by RTA Kottayam the application for the grant of fresh permit on the route Mallappally–Edamon **is granted** for a period of 5 years as an ordinary service, subject to the settlement of timings.

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular stage carriage permit on the route **Athikkayam** - **Thiruvalla** (Via) Naranamoozhy, Mukkom, Adichipuzha, Alimukku, Valiyakulam, Jandaikkal, Ozhuvanpara, Ranni PBS, Marthoma Hospital, Aruvickal, Mukkuzhi, Vrindavanam Jn., Chalappally, Ezhumattoor, Kottamkudi, Padimon, Cherthodu, Mallappally, Madukkoli, Chengaroorchira, Kunnanthanam, Paippad, Kizhakkanmuthoor for a suitable stage carriage for a period of 5 years as ordinary service.

Enquiry report of Joint RTO Mallappally reveals that the total route length is $51.7~\rm km$ out of which $50.1~\rm km$ lies in Pathanamthitta district and $1.6~\rm km$ in Kottayam District. This authority on 13/06/2024 considered the application and adjourned for want of concurrence from RTA Kottayam .

On hearing, K.S.R.T.C raised timing objection only. On the strength of concurrence granted by RTA Kottayam the application for the grant of fresh permit on the route Athikkayam - Thiruvalla **is granted** for a period of 5 years as an ordinary service, subject to the settlement of timings.

Item No.3

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular stage carriage permit on the route **Ranni - Thiruvalla (Via)** Ranni PBS, Marthoma Hospital, Aruvickal, Mukkuzhi, Vrindavanam Jn., Chalappally, Ezhumattoor, Kottamkudi, Padimon, Cherthodu, Mallappally, Madukkoli, Chengaroorchira, Kunnanthanam, Paippad, Kizhakkanmuthoor for a suitable stage carriage for a period of 5 years as ordinary service.

Enquiry report of Joint RTO Mallappally reveals that the total route length is 37.4 km out of which 35.8 km lies in Pathanamthitta district and 1.6 km in Kottayam District. This authority on 13/06/2024 considered the application and adjourned for want of concurrence from RTA Kottayam and directed the applicant to submit a modified proposal touching the Perumpuzha bus stand and limiting the overlapping as per GO(P) No 13/2023 Trans dated 03/05/2023.

Concurrence obtained from RTA Kottayam for the portion of their jurisdiction. As per the decision of RTA held on 13/06/2024, the applicant has not submitted modified route proposal. As per the judgment of Hon'ble High Court of Kerala dated 19/11/2001 in OP No 29739/2001 has not complied by the applicant. Moreover the total overlapping on notified routes exceeds more than 5% of the total route length. Hence **rejected.**

Item No.4

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular stage carriage permit on the route **Kozhencherry**—**Ittiyappara Bus stand (Via)** Cherukolpuzha, Edappavoor, Menamthottam, Angadi, MLA padi, Minarva Jn.Perumpuzha for a suitable stage carriagefor a period of 5 years as ordinary service.

Enquiry report of Joint RTO Ranni reveals that the total route length is 16.5 km. Total overlapping length is 2.1km which exceeds the permissible limit of 5% of total route length, that is 0.825 km. As per the judgment of Hon'ble High Court of Kerala dated 19/11/2001 in OP No 29739/2001, all the stage carriages coming and leaving Ranni should pass through Perumpuzha bus stand . So the proposed bus should cover Perumpuzha stand before reaching Ittiyappara bus stand. They cannot skip Perumpuzha stand. If the applicant is ready to conduct service from Ittiyappara bus stand to Perumpuzha bus stand he have to travel a further distance of 1.4 km through the notified route Trivandrum-Kottayam (via) Ranni scheme vide GO(MS)No.145/67 dtd.20/07/1967.Hence the permissible overlapping exceeds limit. Hence rejected.

Item No.5

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular stage carriage permit on the route Chunkappara -Thiruvalla (Via) Perumpetty, Chalappally, Ezhumattoor, Padimon, Mallappally ,Madukkoli, Puthussery, Kadamankulam. Kallooppara, Njalikandam, Kaviyoor temple, Kattamuttathu Jn., Kizhakkanmuthoor, Deepa Junction for a suitable stage carriage for a period of 5 years as ordinary service.

Enquiry report of Joint RTO Mallappally reveals that the total route length is 35.8 km, out of which 700 m between Kaviyoor temple gate to Kattamuttathu Jn. is Virgin portion. Road fitness Certificate obtained from Assistant Engineer LSGD Section Kaviyoor Grama Panchayath.

On hearing, K.S.R.T.C raised timing objection only. On the strength of Road fitness Certificate obtained from Assistant Engineer LSGD Section Kaviyoor Grama Panchayath. , the application for the grant of fresh permit on the route Chunkappara –Thiruvalla is granted for a period of 5 years as ordinary service, subject to produce the vehicle with wheelbase not exceeding 5200mm and settlement of timings.

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular stage carriage permit on the route **Adoor-Padayanippara** (Via) Parakodu, Ezhamkulam, Mamkoottam, Padinjarevila, Chelikuzhy, Kunnida, Kurumpakara, Puthuval, Pathanapuram, Pun nala, Alimukku, Karavoor for a suitable stage carriage for a period of 5 years as ordinary service. The applicant also submitted an application for **temporary permit for four months**.

The total route length is 49.8 km out of which 27.7 km lies in Pathanamthitta district and 22.1 km lies in Kollam District. The Secretary RTA is directed to obtain **concurrence from RTA Kollam** for the portion of the route under their jurisdiction. Hence **adjourned** the application for the grant of fresh regular stage carriage permit
- 2. There is no urgent temporary need for 4 months temporary permit under Section 87 (1) of MV Rules. Hence **rejected** the application for temporary permit for four months.

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular stage carriage permit on the route **Kallumkadavu** –**Kalanjoor** (**Via**) Puthuval, Kurumpakara, Kunnida, Chayalodu, Mount Zion Medical College, Elamannoor, Poothankara, Kudutha for a suitable stage carriage for a period of 5 years as ordinary service.

Enquiry report of Joint RTO Konni reveals that this is an inter district route. The total route length is 16 km out of which 15.2 km lies in Pathanamthitta district and 0.8 km in Kollam District. The counsel for applicant requested this authority to restrict the route portion upto Salempuram and an affidavit submitted in this regard .

On hearing, K.S.R.T.C raised timing objection only. Hence the application for fresh permit on the modified route **Salempuram –Kalanjoor** is granted for a period of 5 years as ordinary service, subject to the settlement of timings.

Enquiry report of Joint RTO Thiruvalla reveals that this is an inter district route. The total route length is 58.8 km out of which 53.67 km lies in Pathanamthitta district and 1.05 km lies in Kottayam District and 4.08 km lies in Alappuzha District. The Secretary, RTA is directed to obtain concurrence from RTA Kottayam and RTA Alappuzha for the portion of the route under their jurisdiction. Hence adjourned.

Enquiry report of Joint RTO Ranni reveals that this is an inter district route. The total route length is 129.4 km out of which 117.5 km lies in Pathanamthitta district and 11.9 km lies in Kottayam District. The applicant did not appear before this authority for hearing. On perusal of records total overlapping route length is 61 km which exceeds permissible limit. Hence this authority directed to submit modified route proposal for limiting overlapping within the permissible limit and **adjourned**.

The total route length is 55.50 km out of which 31.20 km lies in Pathanamthitta district and 24.30 km lies in Alappuzha District. The Hon'ble High Court in its judgment directed this authority to consider the request of the applicant, subject to counter signature of RTA Alappuzha. The judgment of Hon'ble High Court complied by this authority. The route portion of 24.3 km lies under the jurisdiction of RTA Alappuzha, this authority resolve to seek concurrence of sister RTA Alappuzha under KMVR 171. Hence adjourned.

Ajeesh A, a reserve bus is inevitable and application for fresh reserve permit **is granted** subject to the validity of primary permit and compliance of SRO 880/75 dated 29.09.1975

Heard the learned counsel represented the applicant. This is an application for permit variation route in respect of the Stage carriage KL 25 A 911 on the route Anayadi-alimukku via Anayadi, Payyanallor, Peringanadu, Adoor, variation Elamannoor, Puthuval, Pathanapuram, Punnala, Alimukku . The extension of 4 km from Alimukku to Karavoor.

The original permit was granted by the RTA on the route Anayadi to Lakshmipuram. . The proposed variation is for cutting first Trip from Ranni to Chalappally and extending Chalappally via Menamthottam seventh Ranni to trip Hospital, Mukkuzhy, Vrindavanam

Enquiry report of Joint RTO Ranni reveals that proposed extension overlaps a distance of 1.4km from Ranni Ittiyappara bus stand to Ranni Perumpuzha bus stand on Thiruvananthapuram - Kottayam (via) Ranni scheme GO(MS)) 145/67/PW dtd.20.07.1967. As per GO(P) 8/2017 Tran dtd.23/03/2017, the right to operate any new service and to increase the trips in the 31 routes in the Annexure or its portions will be reserved exclusively for state Transport Undertaking. In the above circumstances variation application of stage carriage KL 28 F 0099 is rejected.

Heard the learned counsel represented the applicant. This is an application for permit variation application in respect of S/C KL 31 D 9192 for changing terminus from Mavelikkara to Kochalummoodu by Curtailment of last trip from Kochalumodu to Mavelikkara and also additional trip from Kochalummoodu to Pandalam and Pandalam to Mavelikkara.

On hearing K.S.R.T.C raised timing objection only. Enquiry report of Joint RTO Joint RTO Mavelikkara reveals that additional trip from Kochalummodu to Pandalam (15.2 km) and Pandalam to Mavelikkara(22 km) may helps the early morning travelling public and students. In the above circumstances variation application of stage carriage **KL 31 D 9192 is granted** subject to the settlement of timings.

Item No.24

Heard the learned counsel represented the applicant. This is the request for obtaining **counter signature** in respect of S/C **KL 29 K 5573** for variation of regular permit on the route **Parakkode – KV Jetty** ,Ezhamkulam ,Anandappally ,Thumpamon,Pndalam , Edappone ,Mankamkuzhy ,Mavelikkara ,Muttam ,Nangiarkulangara,Harippad by curtailing the portion on the route from Anandappally to Parakkode and for the deviation of the route from Anandappally to Adoor New PBS via MG Road ,RD office jn.

In the light of the letter of Transport Commissioner No D2/210/2024 TC dated 19/11/2024, there is no prohibition for the renewal of existing permits and grant of permits overlapping in the partial exclusion scheme Kayamkulam-Kulathupuzha and Kayamkulam- Punalur. But the scheme prohibits to grant a permit for private stage carriages for the route from Kayamkulam to Kulathupuzha or Kayamkulam to Punalur. Hence counter signature in respect of S/C KL 29 K 5573 is granted.

Heard the learned counsel represented the applicant.
