Heard the applicant Sri. Anish Mathew Paul in connection with his application for permit on the route Meenpara – Piravom – Ernakulam – Medical College.

Secretary is directed to call for concurrence from RTA, Muvattupuzha. Await production of road fitness certificate for the portion from Puthencruz junction to Kurinji via MJSSA. The applicant has not furnished either the vehicle or the particulars of the vehicle required by Section 70 of the Act. The necessity to evaluate the particulars of the vehicle is emphasized in the judgment of the Supreme Court in Mitilesh Gargh V. Union of India reported in 1992 SC 443. Therefore the applicant is called upon to furnish the particulars and information in relation to the vehicle offered by him, if any, before the matter is taken up for (reliance is placed on the Supreme Court judgment in consideration. Maharashtra SRTC V. Manglur Pir reported in 1971 (2) SCC 222.) Such vehicle, if any, shall be of type II complying with AIS – 052 in terms of Rule 125-C of the CMV Rules, 1989 so as to ensure the minimum standards of safety and comforts of passengers (reliance placed in the judgment in W.A. No. 454/2023 of the Kerala High Court).

It appears that the permit is applied for three different routes. A single application for grant of a single permit for more than one route is not permissible or contemplated under the Act. However, the applicant is allowed to make amendment in the application for permit so as to confine it to a single route of his choice. The application so amended shall be accompanied by suitable time table. Judgment in Vivek Dwivedi V. Prem Narayan (AIR 1999 MP 1) is relied on the facts and circumstances of which being identical to the case under consideration.

The time table so furnished, if any, shall necessarily comply with the provisions of Section 91 of the Act and Section 13 of Motor Transport Workers Act, 1961. **The matter is Adjourned.**.

It appears that the permit is applied for four different routes. A single application for grant of a single permit for more than one route is not permissible or contemplated under the Act. Therefore the application is **rejected**relying on the judgment in Vivek Dwivedi Vs Prem Narayan, AIR 1999 MP 1. The facts and circumstances of which were identical to the case under consideration.

That is to say an application seeking a permit must substantially conform to the requirements envisaged under the provision contained in section 70 of the Act. It is necessary for the RTA to consider all the relevant factors including those required by clauses (b) and(f) of section 70 (1) at the time of quasi-judicial consideration of the application for grant of permit as held by the Hon'ble Supreme Court in MitheleshGargh Vs Union of India (AIR 1992 SC 443).

In this case the applicant has not offered any vehicle. Nor has he furnished the particulars or information regarding the vehicle if any offered by him, even at the time of consideration of the application today. Instead, he has offered a "suitable vehicle" which has no existence at all beyond his own imagination.

The proposed route is hit by an approved scheme of nationalization in relation to the route North Paravoor - Kakkanad via Cheranalloor - Signal junction and Bolgatty palace in as much as the proposed route overlaps the notified route from North Paravoor to Cheranalloor Signal junction for a distance of 12 K.Ms. Notication G.O(P) No. 27/2023/Trans. Dated 27.11.2023. Therefore the application is **rejected.**

- 1. Sri Nawas K.M 4/381, Karippai (H) Choornikkara, Thaikkattukara, Aluvais the permit holder in respect of bus KL 41 A 9467
- 2. The permit is valid up to 24.09.2024
- 3. Sri Sakkir M.A, S/o Abubakker, Matrakat (H) Peringala P.O Kunnathunadu Ernakulam-683016 is the present possessor of the vehicle and operator of the permit as evidenced by the application for renewal by Sakkir without sanction of RTA.
- 4. The application for renewal of permit is preferred by Mr. Sakkir who is not the holder of the permit.
- 5. No person other than the permit holder has any right to make application for renewal of permit.
- 6. The unauthorized transfer of permit and change of possession of vehicle do not confer any right on the possessor to operate stage carriage service.

It is a clear case of trafficking in permit between the permit holder Sri. Nawas and other persons like Sakkir, Aliyar etc.

The powers on functions of this authority is to advance public interest, safety, convenience and comforts of the travelling public and not to promote undue gains to the agents and touts engaged in buying and selling of permits. Unauthorized sale and transfer of permit and change of procession of vehicle are not contemplated in the Act or rules. The commercial interest of the permit holder or other persons is none of the business of this authority.

Mr. Sakkir who is having the unauthorized possession of the vehicle is not the holder of the permit and he has no right to seek renewal of permit under section 81 of the Act. Therefore;

- 1. The application for renewal of permit is **rejected.**

This authority is convinced that the curtailment of trip in contravention of the conditions of the permit has been committed by the permit holder. Therefore issue show cause notice to the permit holder as to why the permit of the vehicle should not be suspended for a period of one month. The matter shall be again placed before this authority to pursue further action.
