Exclusive Head of Account for remitting compounding fee - reg.

The state Government enacted the Kerala Road Safety Authority Act 2007, to provide for the constitution of a Road Safety Authority. A Road Safety Fund also has been established under this. As per section 11(3) of the said Act, Government shall contribute to the fund, every year, an amount equal to 50% of the compounding fee collected in the previous year under section 200 of the Motor Vehicles Act, 1988. For this, Government have sanctioned a new Head of Account exclusively for remitting compounding fee i.e. 0041–102–97 compounding fee under section 200 of Motor Vehicles Act 1988, (Central Act 59 of 1988) for assessing the actual amount to be transferred to the Kerala Road Safety Authority Fund towards Government contribution.

Hence all taxation officers of the Department are hereby directed that the amount collected as compounding fee shall be remitted to the Head of Account-0041 -102-97 compounding fee under section 200 of motor vehicles Act 1988 (Central Act 59 of 1988).

## ORDER

As per the Notification read above, the State Government enacted the Kerala Road Safety Authority Act 2007 to provide for the constitution of a Road Safety Authority for the implementation of road safety programmes in the State, for the establishment of a Road Safety Fund. Section 11(3) of the Act stipulates that the Government shall contribute to the Fund every year, an amount equal to fifty percent of the compounding fee collected in the previous year under Section 200 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988). The Road Safety Commissioner, in his letter read above has suggested to open a new head of account exclusively for remitting compounding fee for assessing the actual amount to be transferred to the Kerala-Road Safety Authority fund towards Government contribution, as specified in the Kerala-Road Safety Authority Act 2007.

Sanction is accorded for the opening of new head(s) of account as shown in Column No (2) below under the existing head(s) of account shown in Column No. (1) in the Detailed Estimates of Revenue 2008-09.
