The following draft of the rules further to amend the Kerala Motor Vehicles Rules, 1989, which the Government of Kerala propose to make, in exercise of the powers conferred by Section 111 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), is hereby published for general information as required by sub-section (1) of section 212 of the said Act.

Notice is hereby given that the said Draft Rules will be taken up for consideration on or after thirty days from the date of publication of this notification and that objections or suggestions, if any, that may be received from any person in respect of the said Draft on or before the date specified above will be considered by the Government. Objections or suggestions, if any, in duplicate, shall be addressed to the Secretary to Government, Transport Department, Government Secretariat, Thiruvananthapuram.

DRAFT RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Motor Vehicles (Amendment) Rules, 2011.

(2) They shall come into at once.

2. *Amendment of the Rules.*—In the Kerala Motor Vehicles Rules, 1989, for sub-rule (2) of rule 280, the following shall be substituted, namely:—

“(2). No vehicle not fitted with pneumatic door shall be registered as a Stage Carriage on and after the 1st day of July 2011:

Provided that every vehicle already registered as a stage carriage shall be fitted with pneumatic doors within one year.”

Explanatory Note

(This does not form part of notification, but is intended to indicate its general purport.)

It has come to the notice of the Government that lack of shutters in city and town services cause accidents. Besides, the opening and closing of the door shutters of those stage carriages which are provided with door shutters also cause accidents while opening and closing shutters. If all stage carriages are provided with pneumatic doors such kind of accidents can be avoided in future. Hence the Government have decided to issue order to fit pneumatic doors in all vehicles registered as Stage Carriage on or after the 1st day of July, 2011 and also to fit pneumatic doors to other stage carriages already registered, within one year from the date of publication of this notification.

The notification is intended to achieve the above object.
