S. R. O. No. 192/2009.—Whereas, representations have been received by Government that the existing rates of hire charges of Autorickshaws and Taxies should be revised;

AND WHEREAS, the Government are satisfied that the conditions have changed since the issuance of directions in Notification issued under G. O. (P) No. 46/2008/Tran. dated the 3rd November, 2008 published as S. R. O. No. 1119/2008 in the Kerala Gazette Extraordinary No. 2375 dated the 3rd November, 2008 and that it is necessary to modify the directions issued to the State Transport Authority and the Regional Transport Authorities in respect of the hire charges of Autorickshaws and Taxies in the said notification;

Now, Therefore, in exercise of the powers conferred by clause (i) of sub-section (1) of section 67 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) and in supersession of the direction in notification issued under G. O. (P) No. 46/2008/Tran. dated the 3rd November, 2008 published as S. R. O. No. 1119/2008 in the Kerala Gazette Extraordinary No. 2375 dated the 3rd November, 2008, the Government of Kerala hereby issue the following directions to the State Transport Authority and the Regional Transport Authorities in the State as follows:—

DIRECTIONS

The State Transport Authority or the Regional Transport Authorities, as the case may be, shall refix the fares of contract carriages specified in column (1) of the Schedule below, at the rates shown in the corresponding entries under column (2) thereof, namely:

Hire Charges .

1. Autorickshaws

2. Motor Cabs (including tourist Motor Cabs and ordinary motor Cabs) with a seating capacity of not more than seven persons including driver

- Minimum hire charges will be Rs. 10 for a distance up to 1.50 Kilometre. Beyond the minimum the rate will be Rs. 5.50 per Kilometre and 50 paise for every 1/11 Kilometer or part thereof.
- Rs. 7 per Kilometer for motor cabs (both-petrol and diesel) subject to a minimum of Rs. 50 for a distance up to 4 Kilometres.
- In the case of Air-conditioned Motor Cabs, 10% of the hire charges may be charged additionally.

In the case of Autorickshaws, an additional charge at the rate of 50% of the above rate of hire charges may be charged for journeys performed between 10 p.m. and 5 a.m. in Corporation areas of Thiruvananthapuram, Kollam, Kochi,

Thrissur and Kozhikode and in the major towns of Kannur, Palakkad and Kottayam. In other places, an additional charge at the rate of 50% of the charges shown in the meter, less the minimum hire charges of Rs. 10 may be charged when onward journey alone is performed and the metered charges only when return journey is also performed.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government have decided to reduce the rates of hire charges of Autorickshaws and Motor Cabs in the State taking into account the fall in prices of fuel and the report on revising Price Index for Autorickshaw/Taxi Operations (PIATO) submitted by the National Transportation Planning and Research Centre (NATPAC).

The notification is intended to achieve the above object.
