## **NOTIFICATION**

S.R.O.No.-----2013.- In exercise of the powers conferred by clauses (r) and (uu) of rule 2 of the Kerala Motor Vehicles Rules, 1989 and in modification of the existing notification in respect of the areas of jurisdiction of regional Transport Office, Kottayam and sub – Regional Transport Offices at Changanassery, Kanjirappally, Pala and Vaikkom the Government of Kerala hereby notify the area of Sub-Regional Transport Office, Uzhavoor, and redefine the areas of Regional Transport Office, Kottayam and Sub Regional Transport Offices at Changanassery, Kanjirappally, Pala and Vaikkom as follows, namely:-

- (1) The Regional Transport Office, Kottayam shall have jurisdiction over the Kottayam Taluk, Changanassery Taluk, Kanjirappally Taluk, Meenachil Taluk and Vaikkom Taluk.
- (2) The Sub Regional Transport Office, Changanassery shall have jurisdiction over Changanassery Taluk.
- (3) The Sub Regional Transport Office, Kanjirappally shall have jurisdiction over Kanjirappally Taluk.

- (4) The Sub Regional Transport Office, Pala shall have jurisdiction over the following villages in the Meenachil Taluk, namely:-

## **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G.O.(Ms) No.61/2012/Trans dated 09/10/2012 Government of Kerala have sanctioned eight new Sub-Regional Transport Offices including Uzhavur. Therefore, Government have decided to bifurcate and redefine the areas of Regional Transport Office, Kottayam, Sub-Regional Transport Office, Changanassery, Sub-Regional Transport Office, Kanjirappally, Sub - Regional Transport Office, Pala, Sub - Regional Transport Office, Vaikkom and redefine the area comprising Sub - Regional Transport Office, Uzhavoor within the Kottayam region.
