
I am directed to refer to representations received from various Para-Military and other organizations regarding registration of their BS III/IV special purpose vehicles (armoured and other specialized vehicles) used for operational purposes for the maintenance of law & order and internal security.

- 2. In this regard it is to say that in terms of sub-Rule 18(ii) of Rule 115 of CMV Rules 1989 and on the basis of legal advice received from Ministry of Law & Justice and the learned Law officer, necessary changes are being incorporated in the VAHAN portal to accommodate the registration of BS III/IV special purpose vehicles. Such vehicles may get registered as under:-
 - Ownership type: Central/State Government Police, Law Enforcement and Central Government organisation
 - Vehicle type: Additional type to be created i.e. Armoured vehicle and Other Specialised vehicles.
 - Registration Process to be followed: -

Sl. No	Vehicle type	Registration procedure
1.	Armoured Vehicle	On receipt of application along with the letter of an officer, not below the rank of DIG of the applicant organization, specifying the vehicle type, use of vehicle, type approval certificate, alongwith approval of State/UT Admin, the RTO concerned shall enter the details of the vehicle on the portal under the above mentioned ownership type and vehicle type. NIC shall provide the facility in VAHAN portal to select the emission type manually -BS III or BS IV- for such vehicles.
2. Maria	vehicles	
		The approval of the State Admin shall be mandatory for final registration and generation of registration mark.
