In exercise of the powers conferred by clause (f) of sub-section (2) of section 28 of the Kerala Motor Vehicles Taxation Act, 1976 (19 of 1976), the Government of Kerala, hereby make the following rules further to amend the Kerala Motor Vehicles Taxation Rules, 1975, namely:-

#### RULES

- 1. <u>Short title and commencement-</u> (1) These rules may be called the Kerala Motor Vehicles Taxation (Amendment) Rules, 2023.
- (2). They shall come into force at once.



2. <u>Amendment of the rules:</u>- In the Kerala Motor Vehicles Taxation Rules,1975,(i) in sub-rule (3) of rule 12, for the words, symbol and figures "A fee of ₹.50", the words, symbol and figures "A fee of ₹.100", shall be substituted;

(ii) in sub-rule (2) of rule 13, for the words, symbol and figures "A fee of ₹.100" the words, symbol and figures "A fee of ₹.200" shall be substituted.

#### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Consequent to the Budget announcement in para 541 of the Budget Speech for year 2023-2024, Government have decided to enhance the fee for filing appeal under section 23 and revision under section 24 of the Kerala Motor Vehicles Taxation Act, 1976 (19 of 1976) before the respective authorities, by amending the Kerala Motor Vehicles Taxation Rules, 1975.
