Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The General Manager, Product Design and Development Division, Toyota Kirloskar Motor Private Limited informed the Government of Kerala that they have imported a Hydrogen Fuel Cell Electric Vehicle (FCEV) named Toyota MIRAI to India to participate in the proposed pilot projects of the Government of Kerala and requested to consider 100% waiver of road tax as the vehicle is proposed to be used in Research and Development activities like road tests in Indian climatic conditions, infrastructure evaluations including hydrogen refuelling, etc. Government have examined the request and decided to exempt the Toyota MIRAI from payment of motor vehicles tax under section 22 of the Kerala Motor Vehicles Taxation Act, 1976 (19 of 1976), subject to the condition that the vehicle shall be used for Research and Development purposes for three years by Sree Chitra Thirunal College of Engineering (SCTCE), Thiruvananthapuram and exclusively for the projects approved by Ministry of Road Transport and Highways (MoRTH), Government of India.
