Confidential Assistants of the nodal officers shall take all e-application from any mode and keep a register of such application.

The staff can also submit their grievances to Transport Commissioner through whatsapp in the number 8547639080

The nodal officers shall acknowledge the receipt of the grievances and shall give a reply within seven days from the date of receipt of the same. In case of any difficulty the staff can directly contact Transport Commissioner in public grievance number 8547639090

CA to Transport Commissioner will keep a register for the complaints and shall submit a weekly action report to Transport Commissioner every Monday. JTC/ Sr. AO/ Sr. DTC (Tax)/ Sr. FO will submit an action taken report of all the petition to Transport Commissioner on every Monday and also to discuss personally all such files in person within two days of the receipt of the complaint.

No officers from subordinate offices are permitted physically to visit the Transport Commissionerate till the Covid protocols are lifted by Government.

DTCs/ RTOs/ Joint RTOs shall not give permissions to their staff to visit Transport Commissionerate in person and advise them to file their grievances if any through online.
