In order to give a distinctive identity to the Electric Vehicles (battery Operated Vehicles), it was mandated that the registration mark shall be exhibited in yellow colour on a Green background for transport vehicles and for all other vehicles cases, in white colour on green background through the Ministry's notification for amendment in the Central Motor Vehicles Rules, 1989 issued through G.S.R 749(E) dated 7th August, 2018 (copy enclosed).

- It is also clarified that above mentioned notification and the provision of green colour background number plate is applicable for both, new as well as the existing Battery Operated vehicles.
- It is requested to ensure compliance and that the Battery Operated Vehicles carry the registration plate s with a green background only.

G.S.R. 749(E).—Whereas, the draft rules further to amend the Central Motor Vehicles Rules, 1989 were published, as required under sub-section (1) of section 212 of the Motor Vehicles Act, 1988 (59 of 1988), vide notification of the Government of India in the Ministry of Road Transport and Highways vide number G.S.R. 453 (E), dated the 15th day of May, 2018, in the Gazette of India, Extraordinary, Part II, Section (3), Sub-section (i), inviting objections and suggestions from all persons likely to be affected thereby before the expiry of the period of thirty days from the date of which copies of the Gazette containing the said notification were made available to the public;

And whereas, copies of the said Gazette notification were made available to the public on the 15th day of May, 2018.

And whereas, the objections and suggestions received from the public in respect of the said draft rules have been considered by the Central Government;

Now, therefore, in exercise of the powers conferred by section 64 of the Motor Vehicles Act, 1988 (59 of 1988), the Central Government hereby makes the following rules further to amend the Central Motor Vehicles Rules, 1989, namely: -

- Short title and commencement. (1) These rules may be called the Central Motor Vehicles (10th Amendment) Rules, 2018.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- In the Central Motor Vehicles Rules, 1989, in rule 50, after sub-rule (2), the following sub-rule shall be inserted, namely: -

"2A. In case of Battery Operated Vehicles, the registration mark shall be exhibited in Yellow colour on Green background for transport vehicles and for all other cases, in White colour on Green background.".
