S. R. O. No. 111/2018.—WHEREAS, Government of India have included Jawaharlal Nehru National Urban Renewal Mission Scheme under the Economic Stimulus Package and allotted low floor air-conditioned and low floor non air-conditioned buses for conducting service in Thiruvananthapuram and Kochi Corporations;

AND WHEREAS, representations have been received by the Government of Kerala from the Kerala State Road Transport Corporation that, fares for low floor air-conditioned and low floor non air-conditioned buses under Jawaharlal Nehru National Urban Renewal Mission Scheme now in operation at Thiruvananthapuram, Kochi and Kozhikode Corporations be

revised in view of the rise in the price of diesel, and other allied factors which affect the operational cost since the rate was last fixed on 20th July 2013;

AND WHEREAS, the Government after examining the request are satisfied that it is necessary to revise the rates of fares of the low floor air-conditioned and low floor non air-conditioned buses operated by the Kerala State Road Transport Corporation under Jawaharlal Nehru National Urban Renewal Mission Scheme;

Now, THEREFORE, in exercise of the powers conferred by clause (i) of sub-section (1) of Section 67 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), and in supersession of the directions issued in the notification issued under G.O. (P) No. 76/2013/Tran., dated 19th July, 2013 published as S.R.O. No. 565/2013 in the Kerala Gazette Extraordinary No. 2123 dated 20th July 2013, the Government of Kerala hereby direct the State Transport Authority and the Regional Transport Authorities in the State as follows:—

DIRECTIONS

The State Transport Authority or the Regional Transport Authorities, as the case may be, shall fix the rates of fares of low floor air-conditioned buses and low floor non air- conditioned buses under Jawaharlal Nehru National Urban Renewal Mission Scheme in the State as follows, with effect from 00.00 hours on 1st day of March, 2018. The fare for each stage of low floor air-conditioned buses will be rounded to multiple of two rupees and of non air-conditioned low floor buses to next one rupee.

Type of Buses	Minimum Fare (₹)	Maximum kms. for minimum fare	Fare per km. (after minimum fare)	Distance of fare stages after the minimum charge
Low floor Air- conditioned	20	5 kms.	1.50	2.5 kms.
Low floor Non Air- conditioned	10	5 kms.	0.80	2.5 kms.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The fare of the air-conditioned and non air-conditioned low floor stage carriages under Jawaharlal Nehru National Urban Renewal Mission Scheme operated by Kerala State Road Transport Corporation was fixed as per G. O. (P) 76/2013/Tran., dated 19th July, 2013. The Managing Director, Kerala State Road Transport Corporation forwarded a proposal for the revision of fares for low floor air-conditioned buses and low floor non air-conditioned buses under Jawaharlal Nehru National Urban Renewal Mission Scheme in view of the rise in hike of diesel and other allied factors which affect the operational cost.

Government have examined the matter in detail and decided to enhance the rates of the low floor air-conditioned buses and non air-conditioned buses under Jawaharlal Nehru National Urban Renewal Mission Scheme in the State.

The notification is intended to achieve the above object.
