S. R. O. No. 112/2018.—WHEREAS, the Kerala State Road Transport Corporation has submitted a proposal before the Government of Kerala for revision of fares of multi axle Volvo/Scania services in the State, after assessing the running cost of these services which are being operated in other States;

AND WHEREAS, the Government are satisfied that it is necessary to revise the fares of the multi axle Volvo/Scania bus services operated by the Kerala State Road Transport Corporation on par with the rates of such services operated in the neighbouring States which enter the State of Kerala;

AND WHEREAS, Government after considering the proposal of Kerala State Road Transport Corporation and all other aspects including the increase in cost of diesel and all other factors affecting the operational cost from the last fare revision, satisfied that condition have been changed since the publication of the Notification issued under G. O. (P) No. 42/2014/Tran., dated 7th June, 2014 published as S. R. O. No. 349/2014 in the Kerala Gazette Extraordinary No. 1443 dated 9th June, 2014 and that it is necessary to modify the direction issued to the State Transport Authority by the said notification.

Now, THEREFORE, in exercise of the powers conferred by clause (i) of sub-section (1) of section 67 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Government of Kerala hereby direct the State Transport Authority and the Regional Transport Authorities in the State as follows:—

DIRECTIONS

The State Transport Authority or the Regional Transport Authorities, as the case may be, shall fix the minimum fares of multi axle Volvo/Scania bus services at ₹ 80 and the per kilometre rate as 200 paise, with effect from 00.00 hours on the 1st day of March, 2018. The maximum distance that can be travelled in the above services on payment of minimum fare shall be fixed as 20 kilometres. While calculating the fare, the above said per kilometre rate shall apply over and above the minimum fare, rounding the fraction to the next higher multiple of ₹ 10.

Explanatory Note
