### NOTIFICATION

S. R. O. No. 113/2018. WHEREAS, the Kerala State Road Transport Corporation has submitted a proposal before the Government of Kerala in relation to the operation of Super Air Express Bus services and fixation of fares of such services in the State, after assessing the running cost of these services which are being operated in other States; 33/759/2018/S-15.

AND WHEREAS, the Government after examining the request, referred the issue to Justice Ramachandran Committee constituted vide G. O. (Ms.) No. 61/2010/Tran., dated 19th August, 2010, for advising the Government on fare revision and fixation among other things;

AND WHEREAS, Justice Ramachandran Committee submitted its 25th Report dated 22nd November, 2017 on the fixation of fare after considering the hike in the price of diesel and other operational costs;

AND WHEREAS, the Government of Kerala after considering the report of the said Committee and the request received from the Kerala State Road Transport Corporation are satisfied that it is necessary to decide on the fixation of fare of newly introduced Super Air Express Buses;

Now, Therefore, in exercise of the powers conferred by clause (i) of sub-section (1) of Section 67 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Government of Kerala hereby direct the State Transport Authority and the Regional Transport Authorities in the State as follows:—

#### DIRECTIONS

The State Transport Authority or the Regional Transport Authorities, as the case may be, shall fix the minimum fares of Super Air Express Bus services at ₹28 and the per kilometre rate as 93 paise, with effect from 00.00 hours on the 1st day of March, 2018. The maximum distance that can be travelled in the above services on payment of minimum fare shall be fixed as 10 kilometres. While calculating the fare, the above said per kilometre rate shall apply over and above the minimum fare, rounding the fraction to the next higher multiple of ₹5.

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

The Kerala State Road Transport Corporation submitted a proposal related to the operation of Super Air Express Bus services and fixation of fares of such services in the State after assessing the running cost of such services, on par with the neighbouring States. Government have considered the request in detail and decided to fix the fares of such services accordingly.

This notification is intended to achieve the above object.
