#### NOTIFICATION

G.O. (P) No. 40 /2020/Tran.

Dated, Thiruvananthapuram 14<sup>th</sup> July, 2020.

WHEREAS, as per notification issued under G.O.(P)No. 34/2020/Trans dated 15<sup>th</sup> June, 2020 and published as S.R.O. No. 395/2020 in the Kerala Gazette Extraordinary No. 1437 dated 15<sup>th</sup> June, 2020, the Government had extended the period of remittance of quarterly tax for the quarter commencing



from the 1<sup>st</sup> day of April, 2020, in respect of non transport vehicles and contract carriages ordinarily kept in the State and transport vehicles other than contract carriages and stage carriages ordinarily kept in the State up to the 15<sup>th</sup> day of July, 2020, since the operators of such vehicles could not operate their vehicles due to the wide spread outbreak of novel corona virus epidemic and hence they were facing acute financial crisis;

AND WHEREAS, the Government are satisfied that the above situation is continuing without any change and the period of remittance of quarterly tax in respect of such vehicles for the said quarter shall be extended further;

NOW, THEREFORE, in exercise of the powers conferred by the proviso to rule 5 of the Kerala Motor Vehicles Taxation Rules, 1975, the Government of Kerala, being satisfied that it is necessary in public interest so to do, hereby extend the period of remittance of quarterly tax for the quarter commencing from the 1<sup>st</sup> day of April, 2020 in respect of the category of vehicles specified in serial numbers 1 and 2 in the Table under the said rule, namely:-

- (i) non-transport vehicles and contract carriages ordinarily kept in the State; and
- (ii) transport vehicles other than contract carriages and stage carriages ordinarily kept in the state,  
up to the 15<sup>th</sup> day of August, 2020.

## Explanatory Note

(This does not form part of the notification, but it is intended to indicate its general purport.)

For the reasons stated in the notification, the Government have decided to extend the period for remittance of quarterly tax for the quarter commencing from the 1<sup>st</sup> day of April, 2020 in respect of non-transport vehicles and contract carriages ordinarily kept in the State and transport vehicles other than contract carriages and stage carriages ordinarily kept in the State up to the 15<sup>th</sup> day of August, 2020.

The notification is intended to achieve the above object.
