Consequent to the promotion of eight Motor Vehicle Inspectors as Joint Regional Transport Officer vide order read as 8th paper above, eight vacancies of Motor Vehicle Inspectors arose in the department. Vide G.O. (Ms) No. 270/2015/GAD dated 19/10/2015 and G.O.(Ms) No. 348/2017/GAD dated 17/11/2017, government have reserved 4 post of Motor Vehicle Inspectors for Special Recruitment from SC/ST category and thus 4 vacancies were reported to Kerala Public Service Commission. The Rank list for the same has been published by KPSC. One vacancy will arise due to retirement of an MVI and no more other vacancies are available during this year, hence

in order to give appointment to the candidates, who will advice by the PSC three vacancies kept apart for the same.

The disciplinary action initiated against Sri Biju P V and Sri Jose Antony under Rule 16 are pending and thus they were provisionally included in the select list. But the disciplinary action initiated against Sri Jenix P S under Rule 15 is pending and the same is not considered while preparing select list. As per Note (iii) to Rule 28 (b) (i) (7) Part II, KS&SSRs, 1958, " *Officers whose names are included in the select list but who are subsequently placed under suspension or against whom criminal proceedings are taken in a Sessions Court or in any other higher Court for grave offences and officers against whom departmental proceedings are taken for the imposition of a major penalty under the disciplinary rules applicable to them, shall not be promoted on the basis of their inclusion in the select list until they are fully exonerated of the charges against them. If the officer is fully exonerated of the charges, he shall be promoted on the basis of his position in the select list to the post which has been filled on a temporary basis pending disposal of the charges against him. If the Officer is not fully exonerated, the Departmental Promotion Committee may consider each case on its own merit. Officers whose names are included in the select list but against whom departmental proceedings for imposing a minor penalty are initiated subsequently, may be promoted on a temporary basis pending disposal of the*

proceedings against them. If the Officer is fully exonerated of the charges the temporary promotion shall be treated as regular promotion and if the Officer is not fully exonerated of the charges, his case may be considered by the Departmental Promotion Committee on merits."

Thus it is decided to supersede Sri Jenix P S due to the pendency of disciplinary proceedings for imposing major penalty. Sri Biju P V and Sri Jose Antony are promoted temporarily as Motor Vehicle Inspector as per Note (iii) to Rule 28 (b) (i) (7) Part II, KS &SSRs, 1958. Their suitability of regular promotion as Motor Vehicle Inspector shall be assessed by placing the case before the DPC. Also Sri Promod T G, Sri Ansar C M and Sri Jayarajan P P are promoted as Motor Vehicles Inspectors in this Department in the scale of pay Rs. 55200 - 115300 under Rule 28(b)(ii) of the General Rules of Part II, KS & SSRs, 1958 subject to the final outcome in O.Ps/W.Ps/W.As, if any, pending before the Hon'ble Kerala Administrative Tribunal/Courts.
