**NOTIFICATION**

Two vacancies of Assistant Motor Vehicles Inspectors have arose in the Motor Vehicles Department, consequent on the retirement of Shri. Suresh Kumar E and Ajith Kumar K S, Assistant Motor Vehicles Inspectors on superannuation on 31/05/2022.

As per the Special Rules for the Kerala Transport Subordinate Service, appointment to the post shall be made by direct recruitment or by transfer from among the members of the ministerial service in the Motor Vehicles Department in the ratio of 4:1. In order to maintain the ratio, the above vacancies are to be filled up through 'by transfer' from among the members of the ministerial service in the Motor Vehicles Department who possess the necessary qualification, and in the absence of qualified hands for appointment by transfer, those vacancies shall be filled up by direct recruitment.

In these circumstances, applications are invited from the members of the ministerial service in the Motor Vehicles Department for the post of Assistant Motor Vehicles Inspector through 'by transfer', who possess the qualifications for appointment to the post of Assistant Motor Vehicles Inspector through 'by transfer' as prescribed in the Special Rules issued vide G.O (P) No. 16/2008/Tran. Dated 07.04.2008 published in the Kerala Gazette S.R.O No. 370/2008 as amended from time to time. The applicants should have acquired the qualifications on or before the date of occurrence of vacancy as detailed above. The applications shall be accompanied by attested copies of the qualifications and Service Book.
