

Whereas in the case of an intersection a non-notified route only cuts across a notified route for onward journey. It is only to enable a private operator plying on the non-notified route to a non-notified route to cut across a notified route. The exceptions sought to be made by Full Bench in the form of municipal limit or village limit is totally erroneous and that the same defeats very object behind the scheme which is for total exclusion of private operation. The consistent view of this court has throughout been that the scheme is law and the same has to preserved and protected in public interest. Any other view taken contrary to the said view would amount to violating the integrity of an approved scheme under Section 68D of the Repealed Act. Any deviation in the scheme may frustrate the entire scheme.

An example posed by the full bench in its Judgement as to what happens when an operator on anon notified route has to cut across a notified route by taking "U" Turn on a notified route and then taking left turn to enter on a notified route was not appropriate. In such case it may not amount to overlapping. It would be intersection. There may be a crossing where there is an island in the center and a private operator in order to go from non-notified route as to make a semi-circle of a notified route. 
