**Order No. A3/158/2023-TC (1) Dated. 30-11-2023**

As per the order read as 6th paper above, the Assistant Motor Vehicle Inspectors are posted to the various Motor Vehicles Check Posts for the period from 12.05.2023 to 11.08.2023. As per the order read as 7th paper above, the aforesaid posting has been extended till the finalization of the General Transfer 2023 in the Motor Vehicles Department. In compliance to the Government orders read above and considering the zonal seniority, willingness of officers as furnished by the Deputy Transport Commissioners concerned, and after considering the vigilance / Government references and the previous postings in check posts, the Committee, constituted as per the Government Orders read as 1st, 2nd, 3rd and 4th above, in its meeting held on 17.11.2023 & 22.11.2023 have recommended to post the following Assistant Motor Vehicles Inspectors as

In the above circumstances, **orders are hereby issued for posting the above Assistant Motor Vehicle Inspectors at the various Motor Vehicles Check Posts for the period from 01.12.2023 to 29.02.2024. This order will come into force with effect from 01.12.2023.** The Regional Transport Officers concerned shall evaluate the performance of these officers. Adverse remarks or satisfactory statement shall be forwarded to this office at least one week before the next period. The controlling officers are strictly

directed to relieve the officers on or before 30.11.2023 AN for taking charge at the Check Post on the date of commencement of duty. Any lapse in this regard will be viewed seriously and action taken against the responsible officers. All Deputy Transport Commissioners are strictly directed that no rearrangement shall be done in this order. Substitute temporary arrangements have to be made by Deputy Transport Commissioners concerned at the offices from which Motor Vehicle Inspectors are given check post duty and forward the compliance report.

As per the judgment read as 5th paper above, the Division Bench of the Honorable High Court of Kerala has made it clear that every step and action shall be taken by the Transport Commissioner to ensure that the provisions of the Road Safety Act, 2007 are implemented in its letter and spirit and that the State and the Transport Commissioner shall not forget the fact that the Kerala Road Safety Authority Act, 2007 is constituted in order to ensure road safety, reduce accidents avoid injuries and fatality. **The writ petition was disposed of directing the Transport Commissioner to ensure that the Enforcement Officers are put back to their Enforcement duties at the earliest. Thus as per the above directions of the Hon'ble High Court, the enforcement Officers are to be put back to enforcement duties. Hence any officers shall not be posted/ substituted from the RT Office (Enforcement) to check post. The Deputy Transport Commissioners shall ensure that the Enforcement activities are carried out unhindered under any circumstances.**

In case any of the officers posted has to be exempted from the Check post duty due to the vigilance enquiry/ recommendation/ as per Government Order or if any officer requests for exempting them from check post duty on compassionate/ medical grounds, the RTO's concerned having jurisdiction of the check post, in consultation with the Deputy Transport Commissioner shall make necessary ad-hoc arrangements by posting an officer from the zone as per the instructions contained in the Government Order read as 1st paper above and

shall inform the Transport Commissioner the same day itself for ratification. **In the case of substitute postings due to the availing of leave by any officer, the substitute posting shall be limited strictly to the leave period, and the officer on return from leave shall continue his turn at the Check post.**
