## **ORDER**

Government are pleased to issue the following orders on Promotion and Posting of officers in the cadre of Joint Transport Commissioner, Senior Deputy Transport Commissioner and Deputy Transport Commissioner in Motor Vehicles Department, with immediate effect on public interest.

1. As per the Select List read as 4<sup>th</sup> paper above, Sri. Shaji Madhavan, Senior Deputy Transport Commissioner (Taxation), Transport Commissionerate is promoted and posted as Joint Transport Commissioner (Enforcement), in the existing vacancy, in the Revised Scale of Pay of Rs.1,12,800/- 1,63,400/- on regular basis under the Rule 28(b)(i) of the General Rules in Part II,KS&SSRs.

Sharief, Regional Transport Officer, Malappuram is promoted notionally as Deputy Transport Commissioner in the Revised Scale of Pay of Rs. 95,600 -1,53,200/- with effect from 17.12.2021, the date on which his immediate junior Sri. M. P. James was promoted as Deputy Transport Commissioner, vide, Government Order read as 2<sup>nd</sup> paper above, under Rule 28(b)(i) of the General Rules in Part II, KS&SSRs.
