#### **ORDER**

As per the order read as 3<sup>rd</sup> paper above, the Hon'ble Kerala Administrative Tribunal has disposed the OA filed by Sri.R.Rajeev, Regional Transport Officer directing the 1st respondent, Government to consider and pass appropriate orders on Annexure A7 representation preferred by the applicant and to consider the claim of the applicant for a transfer against the vacancy which arose on 31.12.2019, along with that of other claimants, if any, and pass appropriate orders on merits as expeditiously as possible, at any rate, before filling up the above vacancy.

2)As per the representation read as 2<sup>nd</sup> paper above (Annexure A7), Sri.R.Rajeev has stated that he was promoted as Regional Transport Officer on 31.10.2017 and posted as such at Regional Transport Office, Idukki. During General Transfer in 2019, the Transport Commissioner has invited applications from the officers and he preferred the Stations at Alappuzha, Pathanathitta & Kollam. But, as per the Government Order read as 1<sup>st</sup> paper above, he has been transferred to Thrissur. Hence, he has requested to transfer him to any of the Regional Transport Offices at Alappuzha, Pathanamthitta and Kollam.

3) Against the representation of Sri.R.Rajeev, the Transport Commissioner, in the

letter read as 4<sup>th</sup> paper above, has reported that Sri.Sajith.V, Regional Transport Officer, Kollam retired from the service on 31.12.2019.

- 4) Government have considered the representation of Sri.R.Rajeev, Regional Transport Officer on the basis of the order of the Hon'ble Kerala Administrative Tribunal and the report furnished by the Transport Commissioner.
- 5) In the circumstances depicted above, Sri.R.Rajeev, Regional Transport Officer, Thrissur is transferred and posted as such in the existing vacancy at Regional Transport Office, Kollam vice Sri.Sajith.V, Regional Transport Office retired from service on superannuation on 31.12.2019.
