The applications for General transfer of employees of the Motor Vehicles Department, for the year 2022 were invited as per the circular read above through SPARK Portal. The draft has been generated online through the SPARK Portal, transfer module which is modeled to suit the general transfer guidelines issued by the Government. The list so generated through the SPARK Portal in the cadre of Senior Clerks / Clerks is appended and published herewith for scrutiny by all concerned.

All officers in the cadre of Senior Clerks / Clerks are requested to go through the list and raise objections if any. The errors noted/ objections may be submitted through the Heads of Offices concerned to the official email id of the Senior Administrative Officer, ao.mvd@kerala.gov.in, within 7 days from the date of publishing the draft list. The objections should be preferred in the proforma appended as **Annexure** - I and substantiated with supporting documents / guoting relevant norms, as the case may be. Incomplete and flimsy objections are liable to be rejected summarily. The officers are also directed to verify their service history in SPARK though their establishments concerned and ensure that there is no discrepancy, since any discrepancy in the service history could vitiate the whole process. In cases where any such discrepancies are found, the same shall be promptly brought to notice by way of filing objection. The onus for the same shall vest with the Heads of Offices/DDOs and the employees concerned. All heads of offices are directed to instruct all the officers in the said cadre to go through the list published online in the department website. Objections preferred after the stipulated time limit or in any format other than **Annexure** - I will not be entertained at any cost.
