## **ORDER**

As per the orders of Hon'ble Kerala Administrative Tribunal, read as 2<sup>nd</sup> and 5<sup>th</sup> paper above, the ad hoc Departmental Promotion Committee (Higher) in the Motor Vehicles Department held on 22.02.2024 decided to revise the respective Select Lists pertaining to Sri. Anoop Varkey, RTO, Sri. Suresh K.R, Joint RTO and Sri. Manu P.R., MVI.The Select List thus prepared has been notified as per the G.O. read as 7<sup>th</sup> paper above.

2) Based on the revised select list, the Transport Commissioner has furnished proposal for the notional promotion of Sri. Anoop Varkey, RTO in the cadre of Deputy Transport Commissioner, Sri. Suresh K. R, Joint RTO in the cadre of Regional Transport Officer and Sri. P. R. Manu, MVI in the cadre of Joint Regional Transport Officer, with effect

- 3) Government have examined the proposal in detail and orders the following promotion and postings with immediate effect on public interest.
- i) Sri. Anoop Varkey, Regional Transport Officer (Enforcement), Wayanad is promoted notionally as Deputy Transport Commissioner, in the Revised Scale of Pay of Rs. 95600-153200/-, with effect from 30.07.2022, the date on which his immediate junior Sri. Joshy K was promoted as Deputy Transport Commissioner vide Government Order read as 1<sup>st</sup> paper above.

The cadre strength of Deputy Transport Commissioner in the Motor Vehicles Department is 4 (Four). During the year 2023, Sri Gokul T. G was promoted to the cadre of Deputy Transport Commissioner in the existing vacancy.
