Consequent to the promotion of five Senior Superintendents as Joint Regional Transport Officers as per the Government order read as 7th paper above and a Senior Superintendent as Accounts Officer as per Government order read as 8th paper above, six vacancies of Senior Superintendents arose in the Department. The following Junior Superintendents who are the senior most persons included in the Select List as per the Notification read as 3rd, 5th and 6th papers above are promoted as Senior Superintendents in this Department in the scale of pay Rs. 51400 -1200- 52600- 1300-56500 - 1400- 60700- 1500- 65200- 1600- 70000 -1800- 79000- 2000-89000- 2200-97800 - 2500 -110300 on a regular basis under Rule 28(b)(i) of the General Rules of Part II, KS & SSRs, subject to the decision in O.Ps/W.Ps/W.As, if any, pending before the Hon'ble Kerala Administrative Tribunal/ Courts.

The Departmental Promotion Committee (Lower) held on 23/12/2020, 20/04/2021, 25/01/2022 and 10/04/2023 decided to supersede Sri Prageesh T M due to the pendency of disciplinary action initiated against him. He had approached the Hon'ble Kerala Administrative Tribunal and the Hon'ble Tribunal in its order dated 22/05/2023 in OA(EKM) No.s 1308 & 1571 of 2021 disposed of the Original Application by setting aside the Memo of charges in Annexure R2(a) in OA(EKM) No. 1308 of 2021 & Annexure A4 in OA(EKM) No. 1571 of 2021. The Hon'ble Tribunal also set aside Annexure A11 order in OA(EKM) No. 1308/2021 (G.O.(Rt)No. 157/2021/TRANS dated 14/05/2021). Thus in compliance to the order of Hon'ble Tribunal, the ad hoc Departmental Promotion Committee (Lower) held on 24/07/2023, considered the case of Sri Prageesh T M in light of the order dated 22/05/2023 of the Hon'ble KAT & decided to revise the Select List of Junior Superintendents for the year 2021 and include him as SI No. 4(a) in between Smt A P Mini and Smt Manjula C V, published vide Notification read as 5th paper above. As his immediate juniors were promoted as Senior Superintendents vide orders read as 1st and 4th paper above, Sri Prageesh T M is notionally promoted as Senior Superintendent w.e.f. 06/05/2021, the date on which his immediate juniors were promoted.

The Departmental Promotion Committee (Lower) held on 25/01/2022 and 10/04/2023 decided to supersede Sri V Sivaprasad due to the pendency of disciplinary action initiated against him. He had approached the Hon'ble Kerala Administrative Tribunal and the Hon'ble Tribunal in its order dated 09/06/2022 in OA(EKM) 696/2022 has disposed of the Original Application by directing the 1st respondent, i.e, the Government to finalize the minor penalty proceedings initiated against him within a period of two months from the date of receipt of a copy of the order and on finalization of the proceedings and subject to the orders rendered therein, the 2nd respondent, i.e, the Transport Commissioner will ensure that the claim of the applicant for promotion as Senior Superintendent is considered by duly convening an ad hoc DPC, if so required. Govt, as per GO(P)No. 389/2023/Trans dated 18.09.2023, have finalized the disciplinary

action initiated against him by awarding a punishment of 'censure'. Thus in compliance to the order of Hon'ble Tribunal, the ad hoc Departmental Promotion Committee (Lower) held on 26/10/2023, considered his case and decided to revise the Select List of Junior Superintendents for the year 2022 and include Sri V Sivaprasad as Sl No. 8(a) in between Smt M N Maya (SL No. 8) and Sri K Chandrakumar (Sl No. 9) published vide Notification read as 6th paper above. His immediate junior was retired from service and the next juniors were promoted as Senior Superintendents vide orders read as 2nd paper above. In the above circumstances, Sri V Sivaprasad is notionally promoted as Senior Superintendent w.e.f. 13/06/2022 the date on which his immediate juniors were promoted.
