Vide order read as 1st paper above, the transfer and postings of Motor Vehicles Inspectors was ordered wherein Sri Shelly O F was transferred from Regional Transport Office (Enforcement) Kannur and posted to Regional Transport Office Kasargod. As he is one of the senior most officer from Enforcement to be posted to office and has not filed any request for retaining him in the Enforcement office he was transferred from Regional Transport Office (Enforcement) Kannur and posted to Regional Transport Office, Kasargod.
