## ORDER NO.A3/9377/2016/TC, Dated; 23/6/2018

Due to the promotion of 2 Junior Superintendents to the cadre of Senior Superintendents, 2 vacancies of Junior Superintendents have occurred in this Department. The following seniormost Head Clerks/Head Accountants/Public Relations Officers, as per the final Seniority List read above, have been considered for promotion to the cadre of Junior Superintendent.

- 1. Smt. C.V:Manjula, SRTO, Chalakudy
- 2. Sri. Balakrishnan K, RTO, Vadakara
- 3. Smt. Lekha S Nair, Transport Commissionerate
- 2) Out of the above officers, Smt.C.V.Manjula, and Sri. Balakrishnan K, were earlier excluded from promotion due to the pendency of Vigilance case and disciplinary proceedings for major penalty under Rule 15 of KCS(CCA)Rules against them. Against the exclusion from promotion, Sri. Balakrishnan K had filed OA (EKM) No. 2485/2017 and OA No. 910 /2018 respectively, before the Hon'ble Kerala Administrative Tribunal. Order dated 07.06.2018 of Hon'ble KAT in OA No. 910 /2018 received in the office, directing to consider Sri. Balakrishnan K for promotion, subject to the availability of vacancy, after taking into consideration the fact that the juniors of Sri. Balakrishnan K have already been promoted and such promotion will be final subject to the outcome of the Original Application. The order of the Hon'ble Kerala Administrative Tribunal have been examined on the basis of the relevant statutory provisions. Probation of Smt C.V.Manjula has not been declared yet due to the pendency of Vigilance Case. Hence Smt. C.V.Manjula is excluded from promotion due to the pendency of Vigilance Case against her and for the non-declaration of probation in the feeder category. Probation of Sri. Balakrishnan K is declared in the feeder category.
- 3) In the above circumstance Sri. Balakrishnan K is provisionally promoted to the cadre of Junior Superintendent in this Department in the Revised Scale of Pay Rs.30700-65400 under Rule 28(b) (ii) of the General Rules of Part II, KS & SSRs, subject to the decision in the O.Ps/W.Ps/W.As, if any, pending before the Honourable Kerala Administrative Tribunal/Courts and subject to the disposal of disciplinary action pending against him.

- 4) Smt. Lekha S Nair in the cadre of HA/RC/PRO, is promoted to the cadre of Junior Superintendent in this Department in the Revised Scale of Pay Rs.30700-65400 under Rule 28(b) (ii) of the General Rules of Part II, KS & SSRs, subject to the decision in the O.Ps/W.Ps/W.As, if any, pending before the Honourable Kerala Administrative Tribunal/Courts.
